Please be advised, Madison County will receive by electronic transfer a distribution from the Mississippi Elections Support Fund (311E) in the amount of \$48,126.12. Our office is authorized to make this payment by the Mississippi Legislature.

Pursuant to Section 23-15-5, Miss. Code Ann., these funds must be

held in a separate fund solely for the purpose of acquiring, upgrading, maintaining or repairing voting equipment, systems and supplies, hiring temporary technical support, conducting elections using such voting equipment or systems, employing such personnel to conduct an election and training election officials.
