Proposed Amendment for Expansion of Mount Helms Road Pit and Solid Waste Facility

Notice is hereby given that Southern Environmental Group, Inc., with a mailing address of 495 Mount Helm Road, Brandon, Mississippi 39047 has submitted a request for amendment to the Rankin County Solid Waste Management Plan. This request is seeking to allow for expansion of the existing Class I Rubbish Site operating as Mt. Helms Road Pit and Solid Waste Facility located at 495 Mount Helm Road, Brandon, Mississippi 39047, and in Section 29, Township 7 North, Range 4 East, Rankin County, Mississippi. The proposed expansion would increase the existing permitted 76-acre site with a 50-acre disposal area to a 96-acre site with a 68-acre disposal area accepting rubbish material including construction and demolition debris, plastic, paper, glass, metal, wood, concrete, furniture, and appliances. The facility is requesting a service area of Rankin, Hinds, Madison, Copiah, Leake, Scott, Simpson, and Smith Counties, Mississippi.

A public comment period begins July 25, 2018 and ends at 9:00 A.M. on September 4, 2018. Documents related to the proposed amendment are available for review at the Rankin County Board of Supervisors Office at 211 East Government Street, Suite A, Brandon, Mississippi 39042. Comments may be submitted in writing to the Supervisors Office at the address above, or submitted in person by attending a public hearing to be held in the Board Room of the Rankin County Courthouse Annex at 9:00 A.M. on September 4, 2018.
