	Agreement, between the "Customer" named above and State Industrial Products Corp. (State), is effective months from the date of acceptance by State. This Agreement will automatically renew for successive month periods following the initial period unless terminated as set forth below.
1)	Customer shall be responsible for the proper storage and maintenance of materials and dispense equipment provided under this Agreement. Damaged or lost dispenser equipment provided under this Agreement will be charged to the Customer at the then current list prices. Defective dispense equipment will be repaired or replaced by State, at State's sole discretion.
2)	State will provide limited service on all dispensers, including replacement of wearable parts, dispense installation, set-up and dispenser maintenance during the term of this Agreement.
3)	The price for products purchased by Customer shall be based on the current state contract identified as ("Contract"). Prices will change on
	if changed under the terms of the Contract. Customer is responsible for any applicable taxes. Paymenterms of sale shall be net 30 days from date of invoice by State.
4)	The Agreement includes only the dispensers, products and services listed on the included Program Equipment and Program Products lists. Additional dispensers, products and services must be purchase separately. Outside of included Equipment Kit Spray Bottles provided by State, Customer will purchase additional spray bottles.
5)	This Agreement may be discontinued by either party with 30 days advance written notice. In the ever this Agreement is discontinued prior to the midpoint of the initial term, customer will be billed by Stat <u>for installed dispensers listed on the included Program Equipment list.</u>
6) 7)	Customer agrees to only utilize State's products in dispenser equipment provided by State if applicable. This Agreement reflects all of the agreements, understandings, representations, conditions and warranties by and between the parties whether oral or written. This Agreement may not be modified or amended except in writing by both parties. This Agreement is subject to acceptance by State Industria Products.
8)	This Agreement shall be deemed to have been entered into in Cleveland, Ohio. Any dispute arisin under this Agreement shall be subject to the laws of the state of Ohio. Venue and jurisdiction for resolution of any dispute shall be any court in Northeastern Ohio.

A minimum of monthly service from a qualified State Industrial representative will be provided. Activities will include equipment installation, preventative equipment maintenance, inventory management and control, bottle re-filling, product and dilution adjustments and monthly documentation and reporting.

Employee training will be provided for all necessary personnel. Training includes, but is not limited to, initial equipment and product training, Green 101 education, safety training and specialty on-site clinics. Training is also available online in the form of short webinars ideal for follow-up and new hire orientations. All programs come with color-coded product application wall charts and standard operating procedure manuals complete with Material Safety Data Sheets.

Primary custodial products will dispense through State's One SolutionTM Dilution System. Dilution rates will be customized and set on-site and can be adjusted based on employee feedback and management approval. This closed loop dispensing system ensures chemical will be consistently and accurately dispensed, making the program virtually error and tamper proof. All packaging and secondary containers are color-coded, available in English, Spanish and French and are OSHA compliant. By using the One SolutionTM Dilution System, you will reduce both chemical and labor costs. You have eliminated the need to ship water, thus reducing end-use-cost and freight charges. Typical ready-to-use products in the marketplace range in price from \$3.00 - \$20.00 per quart. End-use-cost utilizing the State program is pennies per quart.
