ORDER SETTING PRELIMINARY HEARING

- B) CMU water rates for the Commission's jurisdictional customers.

C) CMU sewer rates for the Commission's jurisdictional customers.

D) The status of CMU's various certificates of public convenience and necessity issued by the

Commission.

E) The status of any necessary local and private legislation and/or laws enabling the CMU to

service customers beyond five (5) miles from the City of Canton's corporate limits.

F) The status of CMU's operation of the sewer treatment plant known as Beatties Bluff

Wastewater Treatment Facility, any joint operating agreement regarding said sewer treatment

plant, and any attendant litigation surrounding said joint operating agreement and/or

operation of said sewer treatment plant.

G) The history of transfers of funds from the CMU to the City of Canton Redevelopment

Authority or the City of Canton.

H) Interest CMU pays to customers and/or has paid to customers on customer deposits it holds

pursuant to Miss. Code Ann. § 75-17-1(1) and Public Service Commission Service Rule 9.130.

II) Persons Required to be Present

The Commission finds that the following persons' presence is required, and therefore orders

the same to appear for the preliminary hearing:
