

3. The staff and daily operations of Madison County's Emergency Management Agency (EMA) encourage and foster a two-way dialog between identified responders and members of the community. We achieve this through planning, training, public outreach, and response. The EMPG Program helps support the staffing and daily operational budgetary requirements needed to obtain the stated goals set by our agency to better serve our community as a whole.
