AMENDED AND RESTATED CERTIFICATE OF FORMATION OF

L-3 COMMUNICATIONS VERTEX AEROSPACE LLC

This Amended and Restated Certificate of Formation (this "<u>Certificate</u>") of L-3 Communications Vertex Aerospace LLC (the "<u>Company</u>"), dated as of June 29, 2018, has been duly executed and is being filed by the undersigned, as an authorized person, under Section 18-208 of the Delaware Limited Liability Company Act, to amend and restate the Certificate of Formation of Raytheon Aerospace LLC, which was filed with the Secretary of State of the State of Delaware on June 26, 2001, as amended by that Certificate of Amendment filed with the Secretary of State of the State of Delaware on June 10, 2003, that Certificate of Amendment filed with the Secretary of State of Delaware on December 15, 2003 and that Certificate of Amendment filed with the Secretary of State of Delaware on February 9, 2004 (collectively, the "<u>Original Certificate</u>").
