Commissioner Fisher:

Madison County employs three certified law enforcement officers as County Patrol Officers under MCA Section 45-7-21(2). Their duties are specified in MCA Section 45-7-23 and Sections 45-7-1 through 45-7-5.

MCA Sections 45-7-21 and 45-7-3 excludes a County Patrol Officer from having authority "to enforce the traffic laws, rules and regulations of this state, or any related laws upon any highway of the state highway system", without your authorization and empowerment.

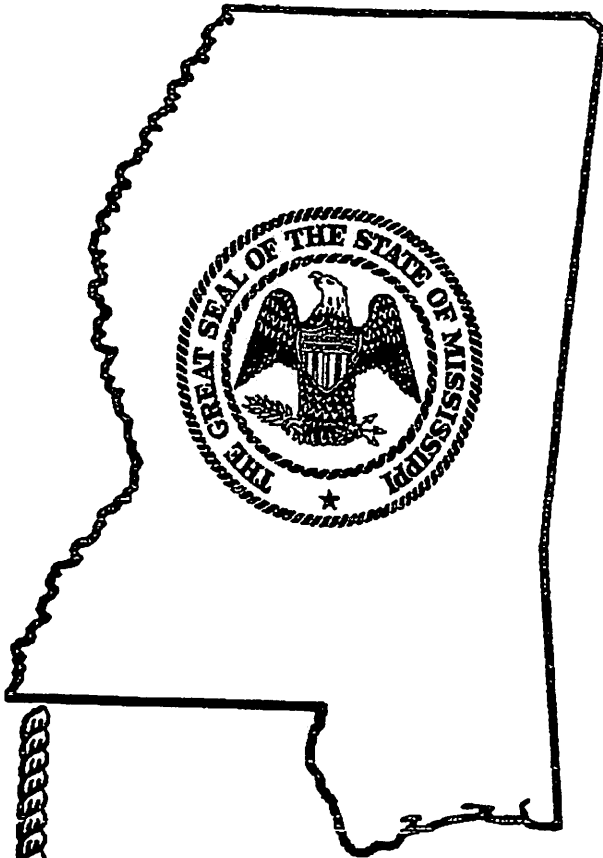
The Madison County Board of Supervisors requests that you authorize and empower our County Patrol Officers to enforce the traffic laws, rules and regulations of this state, or any related laws upon state highways 16, 17, 22, and 43 and U.S. Highway 51 of the state highway system, within Madison County.

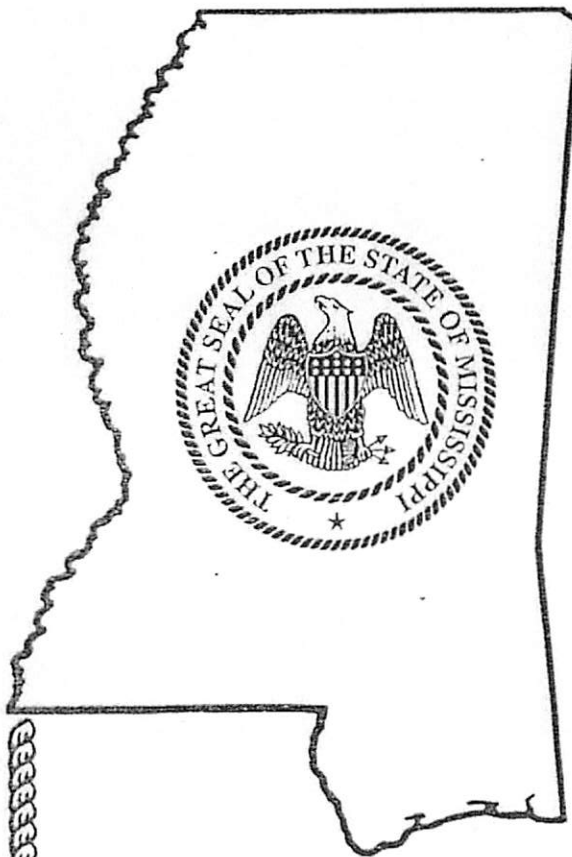

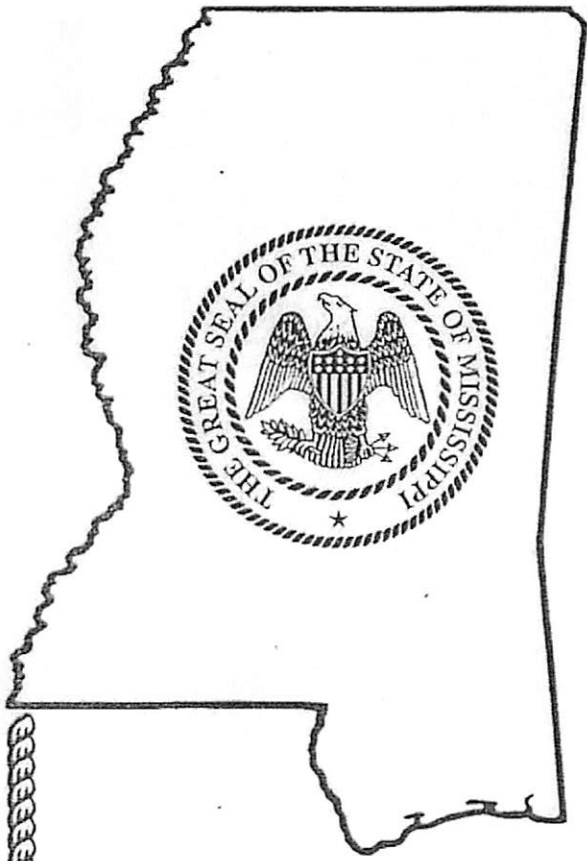
