

HOTEL PAYMENT

Individual reservations will be responsible for paying their own room, taxes, resort fees, and incidental charges. Credit card will be charged at the time of reservation for the first night's room and tax. Checks cannot be accepted after April 21, 2019. A credit card is required at check-in; even for those with rooms being paid for by an agency or another entity, this is for incidental charges at a minimum.

IF PAYING WITH FOR ROOM WITH A CHECK

If you are paying for room with check, the room reservation will be entered as non-guaranteed reservation. Payment for the full amount of room, tax and resort fee for all nights (provided at time of reservation) must be received within two weeks after making the reservation or two weeks prior to arrival (whichever date comes first) If payment is not received within two weeks after making the reservation or two weeks prior to arrival
