Subject: Authority to Purchase Ammunition and Uniforms for Constables

State law (MCA 19-19-1) requires the county to furnish a Constable with the following:

- (1) Two official duty uniforms,
- (2) A blue light,
- (3) Vehicle identification emblems, and
- (4) Any required training (only once per term).

A 1992 Attorney General's opinion (to J.T. Lamar 1/16/1992) states, "that the board, in its discretion, may purchase such equipment as may be proper for a law enforcement office and assign it for the use of the constable."

Funds were included in this year's budget for ammunition for the constables to use for qualifying and firing range practice. Constable Brad Harbour has presented two quotes and requested that I issue a purchase order for this year's ammunition in the amount of \$1,405.00 and uniform items in the amount of \$367.96. Please authorize this purchase.
