

As you are most likely aware, Fresche Solutions USA Corporation ("Fresche USA") acquired Quadrant Software LLC ("Quadrant"), BCD Software LLC ("BCD") and Candescent Softbase LLC ("Softbase") on June 3rd, 2016. We are pleased to announce that we are merging Quadrant, BCD and Softbase into Fresche USA with Fresche USA to be the surviving corporation (the "Merger"). The Merger will be effective on July 1st, 2018 ("Merger Date").
