Registration Information

Registration for the conference must be completed online by visiting www.gcd.msstate.edu. Click "Register for Upcoming Events". There you will find the registration link for the conference. Please see the registration parameters below.

The deadline to complete online registration is June 7. 2019. Be sure you include your guest's name and mark the events that you and your guest will attend. This is needed to assure the correct amount of food is ordered in advance. We cannot make changes in the amount of food ordered after the conference begins.

Registration Parameters

The parameters provided below detail procedures for registering conference attendees. The deadline to complete online registration is June 7. 2019 at 5 p.m.

- A. Vendor and Contract Appraisers must register as a Vendor in order to attend ANY part of the conference
- B. MACA dues cover conference registration for the Assessor and/or Collector and one guest.
- C. The Guest of the Tax Assessor and/or Collector is typically a spouse or a significant other.
- D. If the Tax Assessor and/or Collector <u>IS NOT</u> bringing a spouse or significant other, a Deputy may be the Guest.
- E. If the Tax Assessor and/or Collector <u>IS</u> bringing a spouse or significant other, a Deputy must register and pay the deputy conference fee (\$150.00)
- F. NO SPLITTING!! If the spouse or significant other attends any portion of the conference, then the Deputy must pay the deputy conference fee of \$150.00.
- G. The Deputy registration fee is \$150.00
- H. The guest registration fee is \$150.00
- I. The retired Assessor/Collector fee is \$150.00
- J. There is a separate special registration fee scale for children at conference.
 - a. Youth ages 0-6 there is no fee.
 - b. Youth ages 6-13 the fee is \$75.
 - c. Youth ages 14 and up will be required to register as a regular guest for a fee of \$150.
