Madison County resolved to pursue funding for the replacement of Structure No. SA450000000112 through the Local System Bridge Program (LSBP) through the Office of State Aid Road Construction. On December 17, 2013 State Aid agreed to program the replacement of the bridge with LSBP funds. H1 Services, LLC is working to complete the Preliminary Engineering Phase that was started by Warnock in accordance with the LSBP Contract Agreement.

The services in this Task Order 19-02 include providing support to the Madison County Engineering Department in ROW Acquisition & Utility Adjustment Services for LSBP-45(17). These services are <u>not</u> reimbursable by State Aid relative to the LSBP or State Aid program. These services are additional services to the LSBP and State Aid program.
