This is to advise you that the Tax Assessor of Madison County has proposed the following increase to the assessed value of your real/personal property for fiscal year 2012 as follows:

Parcel Number 103H-33-027/00.00 Amount of Increased Assessment \$11,100

Reason Improvements from Another Parcel

This is an increase in assessed valuation, not taxes. To determine the tax increase that this correlates to, you would have to multiply this amount of increased assessment by the tax rate at the location of the property.
