Pursuant to the offer letter dated August 5, 2019, the Madison County Board of Supervisors offered the owner \$300.00 for the fee simple acquisition of .08 acres of right-of-way for the above-referenced project. This offer was based upon an appraisal by a qualified appraiser. The owner has agreed to a settlement offer of \$400.00 based on their claim of a higher value of the property than as valued by the County. It will cost the County much more than the difference of \$100.00 in additional appraisal and legal costs should the property have to be secured through eminent domain.
