# ABOUT YOUR MEMBERSHIP DUES

**International Dues:** Annual membership dues for the period of January 1 to December 31. Dues are based on membership grade, and are payable by and due January 1, 2019. Failure to pay dues will result in a lapse of your membership.

**District Dues (if any):** Dues as a member of the ITE District in which your preferred mailing address is located at the time of the first dues billing for the year. District Dues are collected by ITE headquarters and remitted in full to your District.

**Section Dues (if any):** Dues as a member of the ITE Section in which your preferred mailing address is located at the time of the first dues billing for the year. Section Dues are collected by ITE headquarters and remitted in full to your Section. Note: ITE headquarters does not collect dues for all Sections; you may receive a separate billing from your Section.
