NOW THEREFORE, the parties hereto do further contract and agree to add the following items of work to the above CONTRACT under the additional terms and conditions as are hereinafter stated:

SPECIFIC SCOPE OF WORK FOR THIS WORK ASSIGNMENT

The CONSULTANT, in accordance with the General Services Agreement, <u>shall provide ROW descriptions</u> and <u>exhibits</u> at Yandell Road and Westfalen Drive near the Dollar General Store for the purposes of drainage structure upgrades in Madison County.

The following engineering services shall be performed by the CONSULTANT on behalf of Madison County in accordance with the CONTRACT at the direction of the County Engineer or his designee, unless otherwise modified by the Madison County Board of Supervisors (MCBOS).

The Scope of Work shall include the following:

PART 1 – FIELD SURVEY & RIGHT-OF -WAY DESCRIPTIONS

The CONSULTANT shall perform a survey to supplement the survey completed in prior Work Assignment to obtain boundaries needed for Right of Way or easement descriptions. The CONSULTANT shall prepare and submit Right-of way descriptions for any additional ROW or Easements needed for the project. County will be responsible for obtaining needed ROW.

SERVICES NOT INCLUDED

- 1. Environmental Permitting
- 2. Appraisals and ROW acquisition.

MAXIMUM ALLOWABLE COST

The CONSULTANT'S fee for completion of this Work Assignment shall be a total sum of **\$7,960**. Services will be billed monthly on an hourly basis for cost incurred during the period, but shall not exceed the total estimated fee without prior written authorization from the Client.
