If the government entity applying for a tag is anything other than a state or an established city or county agency, a copy of the code section, minutes, or document that establishes that entity as a federal, state, county or city government agency or instrumentality must be submitted before a tag can be issued. (Initial application only)
- 4. The tags on all vehicles that are sold, traded, or taken out of service should be returned to this office immediately. All returned tags should be accompanied with a letter of explanation that should contain the VIN number of the vehicle, the tag number assigned and the title number of the vehicle. You may not place an old tag on a new
- All motor vehicles that are issued Tax Exempt Government tags must comply with Miss Code Ann. § 25-1-87, § 27-19-27 and § 27-19-59.
