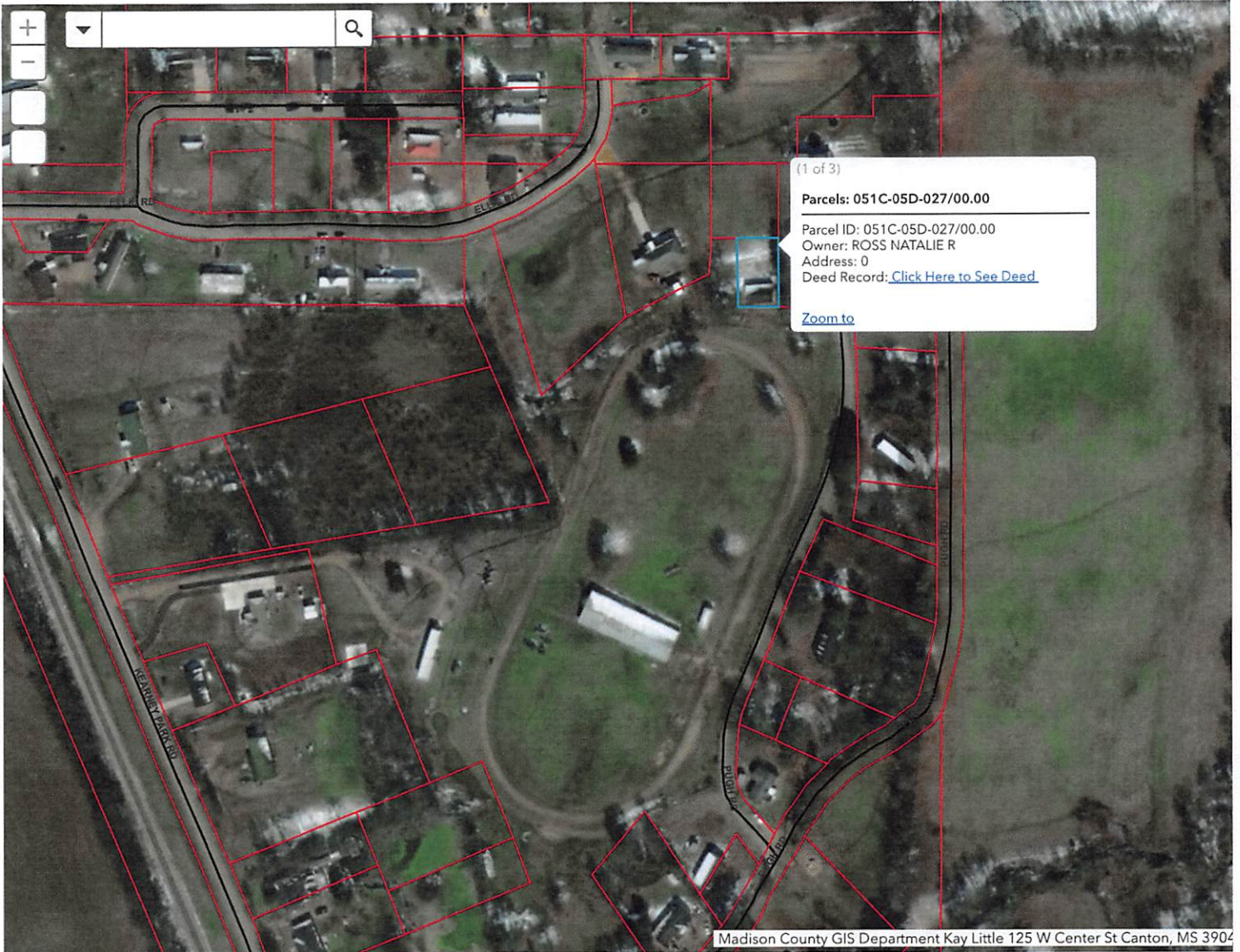
Home Replacement Petition
