Dear Mr. Vance:

This letter and the attachments are being submitted as a budget request for the Madison County Health Department for Fiscal Year 2021. The total operational budget of \$905,437 is necessary to maintain essential public health services for your county and its citizens.

The MS State Department of Health provides core public health functions through various clinical, disease control, Early Intervention Services, High Risk Maternity, and Environmental Health programs. We make patient and client contacts by Physicians, Nurse Practitioners, Registered Nurses, Environmentalists, Nutritionists, STD Investigators, Social Workers, and Case Managers. In addition, as shown on the attached Financial Impact Statement, programs of the Mississippi State Department of Health provide an *estimated economic impact* of about \$2,025,415 per year to Madison County.

As you are aware, Mississippi is combating the spread of COVID-19 and The MS State Department of Health is in the forefront of fighting the spread of COVID-19. As we continue to respond to COVID-19, the county Health Department is already playing a vital role. Staff from across the state are currently participating in contact investigation. Moving forward, the Health Department will continue to do this and will also serve as a location for citizens to be tested and will be a point of distribution for personal protective equipment. In the event a vaccine is developed, the Health Department will also be a major part of vaccine administration.

After reviewing the staffing, budget needs, and expected revenue collections for the upcoming year, we are requesting an appropriation of \$182,440 for Fiscal Year 2021. We are NOT requesting an increase in our appropriation for FY 2021. The request for funding is based on the amount necessary to sustain services at the current level in Madison County. The funds provided by the Board of Supervisors remain in Madison County and are strictly used to fund local salaries, travel, commodities/supplies, and any contractual needs (i.e., cleaning, lawn maintenance, etc.).


