WHEREAS, We, the Board of Supervisors of Madison County, Mississippi, having advertised for bids on the above numbered project and proof of publication of said advertisement having been filed with the Clerk of the Board of Supervisors in the manner and form required by statute, and
WHEREAS, the lowest regular bid was submitted by Beacon Construction, LLC
of Columbia, Mississippi in the amount of \$ 1,017,456.90.
NOW, THEREFORE, IT IS HEREBY ORDERED by the Board of Supervisors of Madison County that the contract be awarded to <u>Beacon Construction</u> , <u>LLC</u>
the contract be awarded to <u>Seacon Construction</u> , <u>LLC</u> subject to approval of the State Aid Engineer, and that the President of the Board be and he is hereby authorized to execute the contract with the Contractor after a satisfactory performance bond has been furnished.
IT IS FURTHER ORDERED that the project fund in the amount of \$\frac{1}{1}06\frac{9}300.00\$ (including 5% contingencies) and an additional amount, limited to 12% of contract construction cost, to cover engineering services of \$\frac{122}{122}\text{100.00}\$, be established by transferring a total of \$\frac{1}{190}\text{400.00}\$ State Aid funds from Madison County's State Aid fund to a project fund and earmarked for this project. The State Aid Engineer is hereby authorized to take such action as necessary to effectuate this transfer. In case of unexpected overruns in costs which would increase the cost of the project beyond the amount of the project fund established herein, the State Aid Engineer is further authorized to transfer additional funds, limited to 10% of the construction costs, to the project fund as are needed to pay such overruns in final construction costs. IT IS FURTHER ORDERED that the President of the Board is hereby authorized to execute Supplemental Agreements to the original contract which do not increase the cost of the project in excess of the project fund authorized herein. It is also ordered that the State Aid Engineer be furnished a certified copy of this order.
