

**Memorandum of Understanding
Between
TWENTIETH CIRCUIT ADULT DRUG TREATMENT COURT
And
FAIRLAND CENTER**

This Memorandum of Understanding is entered into the 3rd day of August, 2020 by and between **Twentieth Circuit Adult Drug Treatment Court**, hereinafter known as 20th ADTC, principally located at 128 N. West Street, Canton, MS 39046, and **Fairland Center** (hereinafter referred to as "Fairland", located at 3000 Highway 495, Tutwiler, MS 38963.

Purpose:

The purpose of the Memorandum of Understanding between 20th ADTC and Fairland is to develop an agreement between both agencies regarding the provision of Mental Health (MH) and Substance Use Disorder (SUD) Treatment services.

Responsibilities:

Fairland agrees to:

1. Provide a designated point of contact to coordinate referrals from 20th ADTC.
2. Based on availability and program capacity:
 - a. Provide MH / SUD screenings and treatment when appropriate for individuals referred by 20th ADTC.
 - b. Provide MH / SUD services for individuals referred by 20th ADTC.
3. Disclose fees for treatment to 20th ADTC prior to treatment being initiated and invoice the 20th ADTC for all services provided when treatment is initiated.
4. Provide invoices for all services rendered for 20th ADTC participants within thirty (30) days of the participants completion of or termination from Fairland Treatment.
5. Provide certification of program completion to the individual upon successfully completing treatment and receipt of payment for services from 20th ADTC.

Twentieth Circuit Adult Drug Treatment Court agrees to:

1. Provide a designated point of contact to coordinate referrals to Fairland.
2. Refer individuals for assessment, MH / SUD services.
