The Madison County Election Commission has determined a need for 33 additional precinct scanners, 10 ballot tote bins, 14 ballot marking devices (including case), and related equipment installation and freight.

This equipment is needed for the upcoming November 2020 election. Therefore, time is of the essence in approving and making this purchase.

Purchase of the items determined to be needed constitute a commodity purchase. State Law requires that such be purchased using reverse auction procedures. This will create a 45-day period before the Board could enter into a purchase agreement – giving less than two weeks for delivery and setup for the November election.

Madison County has received confirmation that the Secretary of State's Office has approved use of HAVA (Help America Vote) Funds for this purchase.

After research for, and consideration of, vendors that could supply such equipment, Madison County made a request for quotes from the following vendors:

Voting Works
Hart Intercivic
Dominion voting
Smartmatic
Election Systems and Software (ES&S)

Using the contact information on Dominion Voting's website, the request for a quote was rejected.

The remaining four vendors submitted a response to our request.

Voting Works – This vendor does not provide a system that is similar to our current election processes. Therefore, an entire replacement and restructuring of our election system would be required. To completely replace our current system with a Voting Works system is estimated to cost \$623,397.

Hart Intercivic – This vendor does utilize a methodology that is similar to our current election processes. However, the equipment does not interface with our existing equipment or software. To utilize this equipment would require a group of precincts to use a new system while others continued to use our existing system. Additionally, the final vote tally would be accumulated by two systems and then manually combined. To place this equipment in service as a second election system, is estimated to cost \$380,586.00.

Smartmatic – This vendor expressed an interest in quoting a solution but declined as they could not have a solution ready the November 2020 election.

Election Systems and Software (ES&S) – This vendor quotes the additional equipment at \$221,686.50. ES&S has provided a letter indicating that they sell proprietary equipment and software. This does not remove the requirement from competitive bidding.

To approve an emergency purchase under our COVID-19 Emergency Declaration, please consider the following and find that:

- 1. To respond to the lingering impact of COVID-19, a situation beyond the control of Madison County, additional equipment (precinct scanners, tote bins, and ballot marking devices) is needed to facilitate appropriate social distancing in voting precincts.
- 2. The time required to advertise for and conduct a reverse auction creates a situation where the resulting equipment purchase cannot occur in time to improve voting conditions at the November 2020 election.
- 3. Madison County has made reasonable efforts to obtain competitive bids for the equipment being purchased.
- 4. Selecting equipment provided by another vendor will create confusion for poll workers and citizens, as there is no ability to interface with the existing election systems.
- 5. Purchasing equipment from the current vendor, who is the lowest and best quote, is the only option available to support and improve voting processes for the November 2020 election,

Therefore, Madison County should initiate an emergency purchase of 33 precinct scanners, 10 tote bins, and 14 ballot marking devices from ES&S. And, if approved, the Purchase Clerk is authorized to issue a Purchase Order for such equipment.

We cannot approve the purchase of the ballot bag per EAC guidance as they do not relate to upgrades to election technology, specifically to Federal Election, or election security. Finding some of the intended expenditures to be allowable under the Help America Vote Act, our office approves Madison County's HAVA Application in the amount of \$233,021.50.

Madison County has \$134,430.15 remaining in the county's 2018 HAVA allotment and \$168,516.13. Reimbursement will exhaust your 2018 allotment, and the remaining balance will be paid from 2020.





Hi Mr. Vance,

We have prepared a spreadsheet for you outlining some of the costs of our equipment and a view of how this might map onto your precincts. This worksheet is in no way a final quote for a voting system, but it may give you some price comparison to begin your analysis.

One important fact to understand in interpreting this worksheet is that VotingWorks does not currently make a precinct scanner equivalent to the DS200, or tote bins. We do make Ballot-Marking Devices (BMDs), and these go with the Encoders and Printer Stations quoted in the sheet. The option envisioned in this quote is that all voters (except absentee and affidavit ballot voters) would vote on BMDs which are ADA compliant, and print their ballots on the Printer Stations. The Printer Station gives a preliminary vote total result at the precinct for mounting on the wall at the precinct, but the official results would be tabulated when the paper ballots are scanned back at election central at the courthouse.

VotingWorks will be building a precinct scanner in 2021, and at that time it would be possible for you to compare our precinct scanner to the DS200 directly. We expect to achieve a favorably competitive price.

This is a quote of precinct equipment only. The cost of the equipment to be used at the courthouse for managing the election, printing paper absentee ballots, and scanning the BMD ballots is not quoted here, nor is ongoing TRUST (technology, return, upgrade, support, and training.)






