# Madison County Veterans Services Office End of Year Report

(October 1, 2019 – September 30, 2020)

#### **Current Operations:**

The Madison County Veterans Service Office was created be the Madison County Board of Supervisors to advise local veterans and their dependents of their rights and entitlements under federal and state laws, to counsel them and to actively assist them by filling out necessary forms and papers and obtaining documents and affidavits so that they can access veteran benefits and services. The office is staffed by Mendal Kemp, (Part-Time) County Veterans Service Officer (CVSO) and Gina Kelley, (Full-Time), CVSO. Kemp and Kelley are Certified CVSOs and receive annual training provided by the State Veterans Affairs Board and pass a test each year in order to maintain Certification.

The work is complex and exacting due to the numerous and ever-changing state and federal laws, rules and regulations. These laws and regulations cover many and varied benefits that include the following: Disability Compensation; Pensions; Insurance; Death Benefits; Healthcare; Special Monthly Compensation; Aid and Attendance; Education and Vocational and Employment and Rehabilitation. Work is generated through inquiries concerning veteran benefits, referrals by state agencies and by actions of the CVSO in seeking out those who may be entitled to benefits.
