We have been in business since 1995

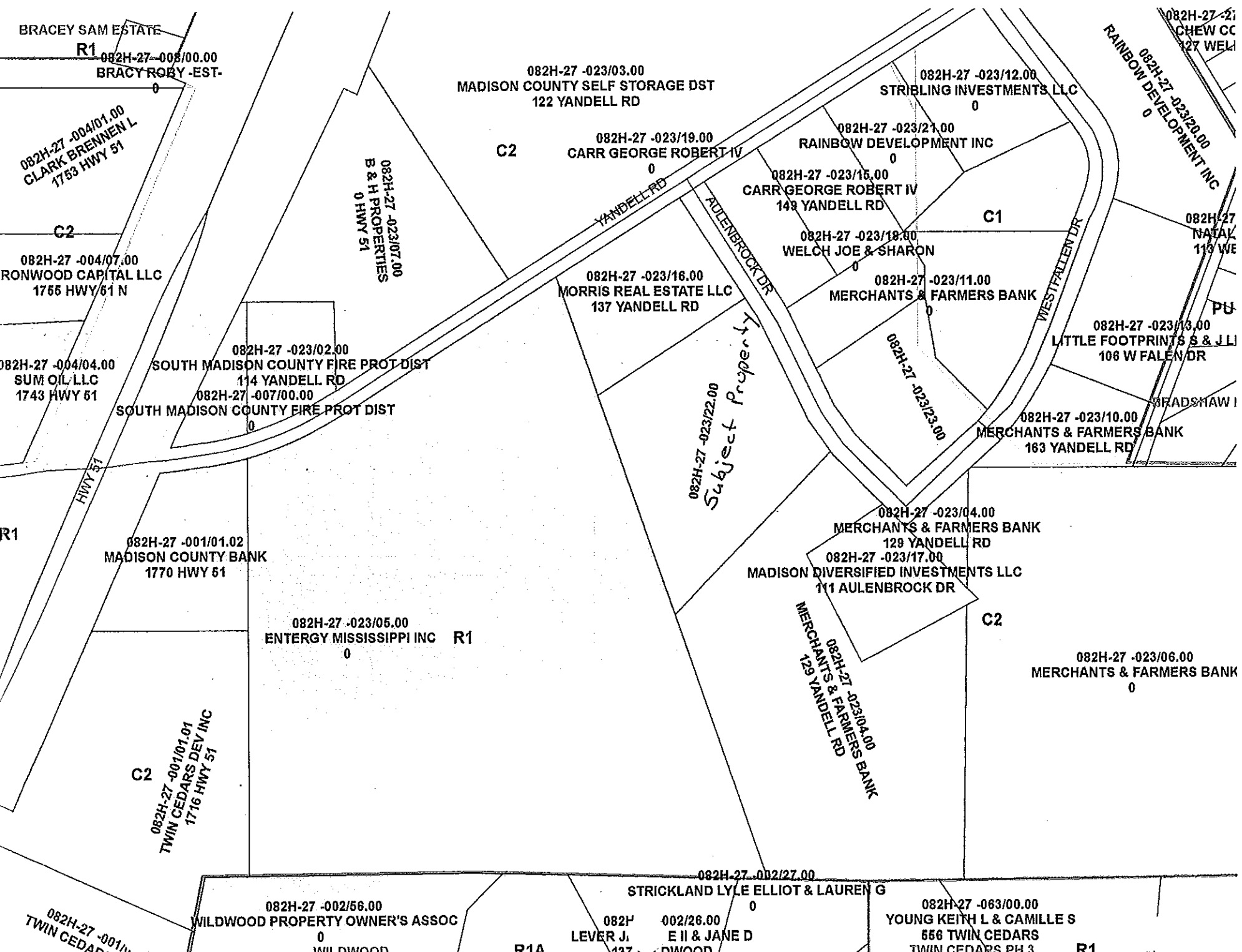
We are a utility contractor, most of our work is placing cable for AT&T

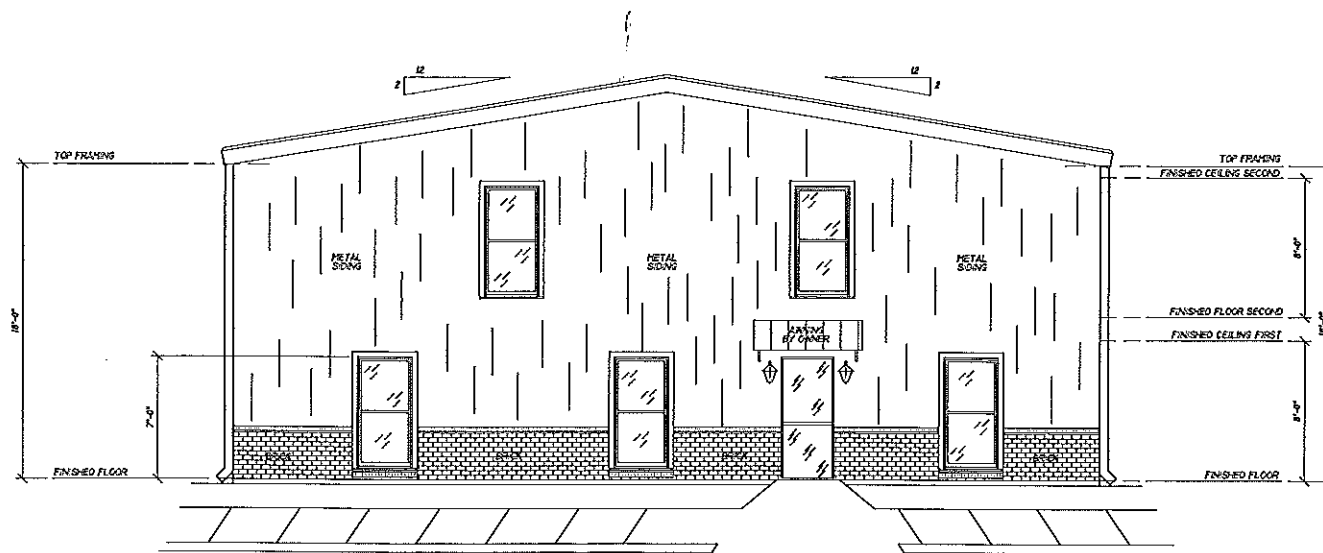

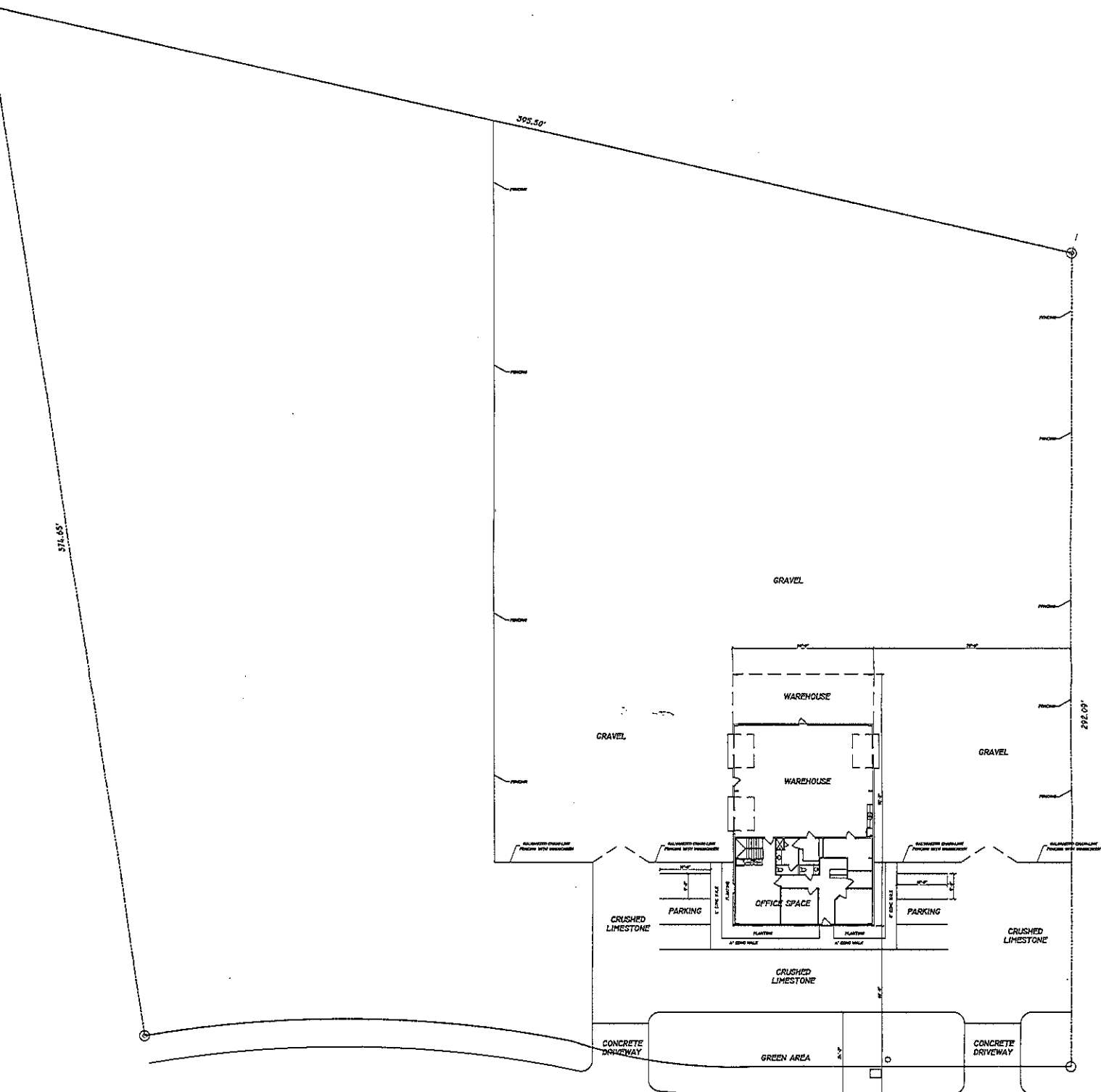
