



SYSTEM PERMISSION FORM

A tenant in your building has ordered an AT&T service that requires a pathway be placed between the property line and the Minimum Point of Entry (MPOE) of your building to facilitate placement of a new AT&T fiber cable needed to accommodate the order. The pathway is the responsibility of the tenant to provide, however, the tenant has asked AT&T to place the pathway, with no cost to you, and AT&T is willing to do so if we have your approval. The pathway will automatically convey to owner at completion, and upgrades or maintenance will be at the owner's discretion; however, it will be placed in accordance with local standards and the area will be restored to original or better condition.

The permission we seek is for the physical structure we will be placing for your tenant only. If we do not receive permission using this form within ten (10) days, the tenant will need to hire another vendor to complete the requirements prior to AT&T delivering the service. AT&T (*Operator) will provide a scope of work prior to installation.

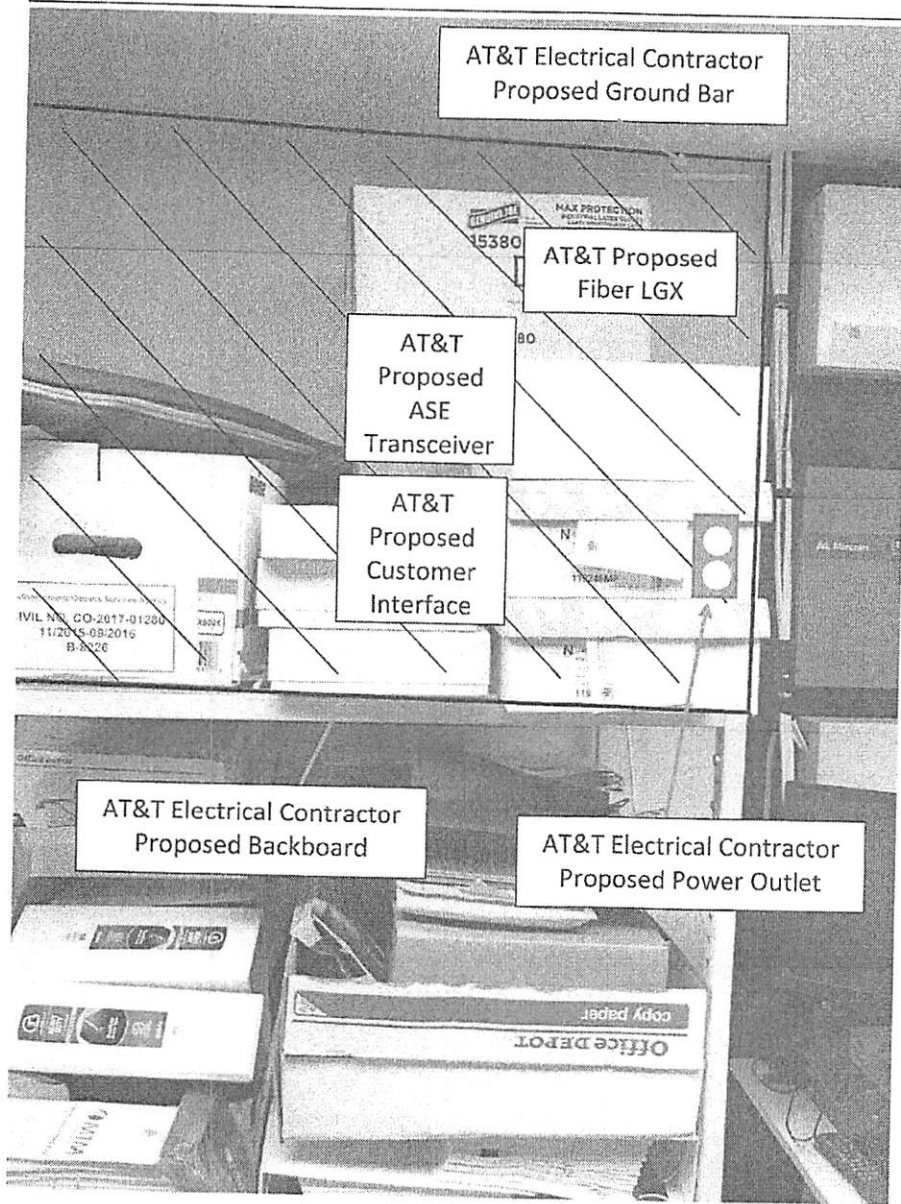

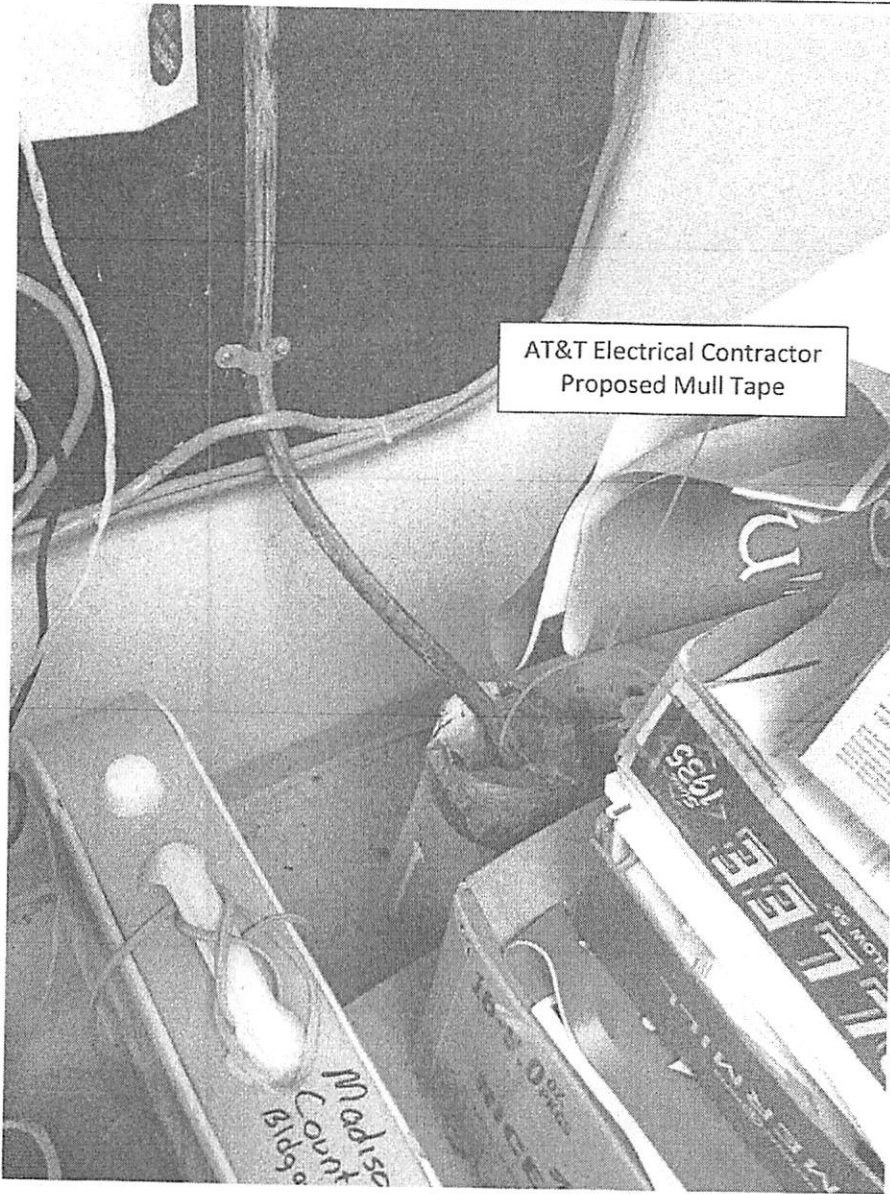

West wall of the DMARC Room



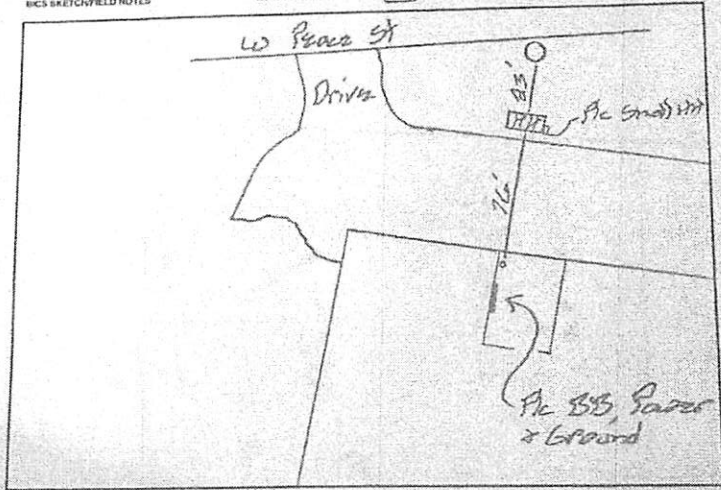
