Re: Request for Closure of Dave Miggins Road
Natchez Trace Parkway

At the Madison County Board meeting on June 3, 1940, the Board established certain crossings as public roads within the boundaries of the Natchez Trace Parkway. One of those crossing was for Dave Miggins Road located at Station 612+50 in Section 18, Township 9N, Range 1E. Madison County does not maintain this crossing and it is not on the 2000 Official Roads Registry and Map.

For these reasons, it is requested that the Board President be authorized to sign the attached letter to the Natchez Trace stating that Madison County does not consider Dave Miggins Road a public road.

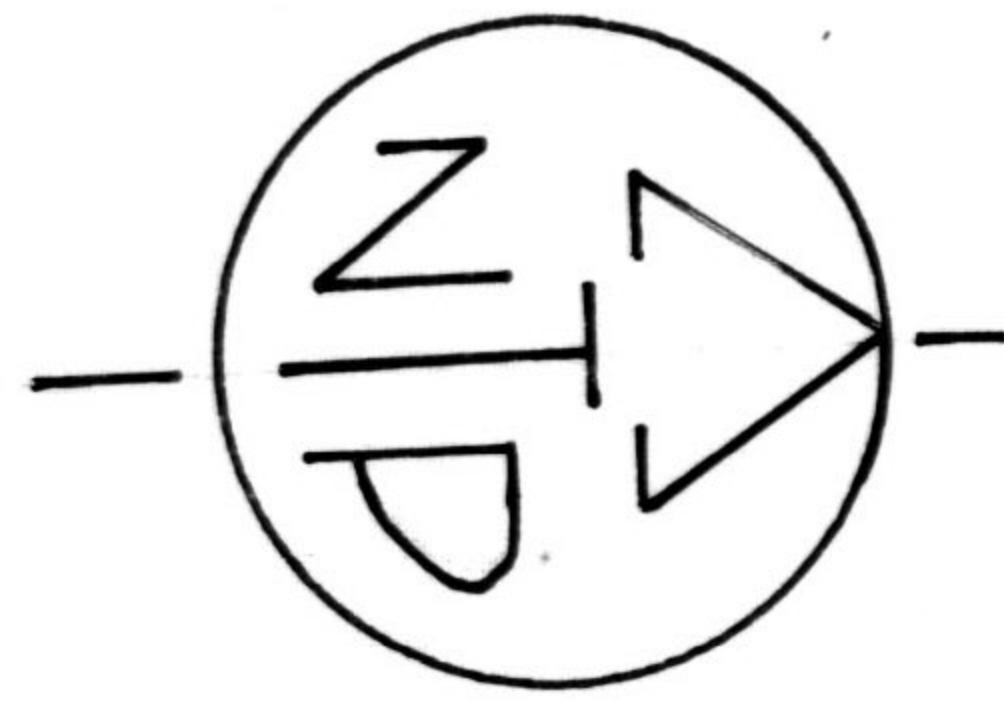
The Madison County Board of Supervisors does not recognize Dave Miggins Road as a public road nor is it maintained by the County.

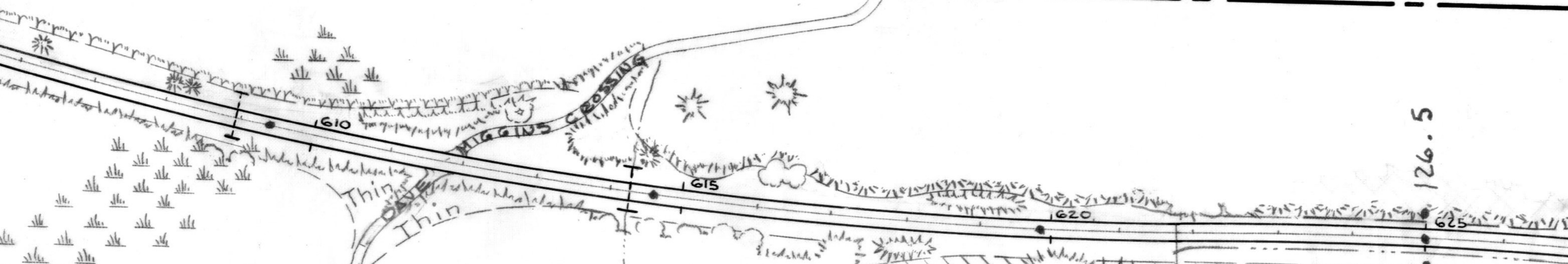
