ORDER TO AUTHORIZE PAYMENT FOR SERVICES RENDERED

THIS MATTER comes before the Court pursuant to Mississippi code section 19-13-31 on petition of Plaintiff Dale Partners Architects, P.A. to request that certain claims and invoices for construction administration services rendered to Defendant Madison County, Mississippi, be paid by Madison County. The Court finds from the pleadings as follows:

1. The parties agree that Dale Partners rendered construction administration services to Madison County and subsequently submit invoices for said services to Madison County.
2. The parties agree that as required by Mississippi law, Madison County has refused Dale Partners' request for payment for said services.
3. The parties agree more specifically that the services rendered by Dale Partners were omitted, by mutual oversight, from the original contract for services between Madison County and Dale Partners; Madison County, therefore, properly denied the claims for payment upon presentment to the Madison County Board of Supervisors.

4. The parties agree that the amount of services performed, and payment due by Madison County to Dale Partners, totals \$26,377.91. Invoices showing the same are attached and incorporated herein.
5. Dale Partners has agreed to waive service of process through its authorized representative and agreed to the form of the order in this matter.

IT IS, THEREFORE, ORDERED that Madison County is hereby authorized, empowered, and ordered to pay the aggregate sum of \$26,377.91 to Dale Architects, P.A. for services received but remaining unpaid by Madison County, and the Clerk of the Madison County Board of Supervisors is hereby authorized to place said sum upon the claims docket for payment by the Madison County Board of Supervisors.

The parties will bear their respective costs. This action is dismissed without prejudice.


