### Memorandum

August 19, 2013

To: Madison County Board of Supervisors

Re: Request for Authority to Refund Land Redemption Funds

Message:

On August 27, 2010, the Madison County Tax Collector struck to the State of Mississippi parcel numbers 081I-32-021 and 071G-36A-063 at the annual Land Sale for Delinquent Taxes.
