Reservation Procedure – Individual call-In: Attendees should make reservations at 1(800)946-2442 and identify themselves as part of the **MS Justice Court Clerks Association (MJC0906)** to receive the special room rate. **Reservations should be made by August 7, 2021.** Any reservation request received after this cutoff date will be honored on a space available basis. If the group rate is not available after **08/07/2021**, the prevailing rack rate will apply. Please bring a copy of your county's tax exempt certificate and it must be presented at the time of check in. The rates are subject to a 7% Mississippi State tax and 2% occupancy tax.

If you are paying with your **county check** please inform the hotel in advance and get total price of your stay. Please make sure the check reaches the designated place fourteen (14) days prior to arriving, Hollywood Casino, 711 Hollywood Blvd, Bay St. Louis, MS 39520.

Check-in & Check-out: Check-in time is 3:00 p.m. and check-out time is 11:00 a.m. Guest check in cannot be guaranteed prior to 3:00 p.m., the hotel will make every effort to accommodate early arrivals and late departures.
