## AMERICAN RESCUE PLAN ACT SEMINAR

MAS has scheduled a one-day seminar on the American Rescue Plan (ARP) process for **September 8, 2021**, in Flowood, MS at the new Sheraton Refuge Hotel & Conference Center. *Tentatively*, the one-day workshop will begin about 9:00 a.m., followed by lunch, then back into the seminar until about 3:00 p.m. The workshop will focus on US Treasury reporting deadlines and ARP guidelines, additional information from NACo and MAS, further discussion on the lost revenue calculator and an open forum for peer-to-peer discussion on best practices and questions.
