COURT APPOINTED APPRAISER



The Court finds that Terry Wells, Certified General Real Estate Appraiser, was appointed by Order of this Court dated the June 28, 2021, to appraise the property which is the subject of this cause, and that said appraiser has filed with this Court and the clerk of the Court the requisite number of copies of the Appraisal Report herein which conforms to that which was ordered by this Court and is subject to the review of this Court. Further the Court finds that Terry Wells has submitted an invoice, a copy of which is attached hereto and made a part hereof, in the amount of One Thousand Dollars (\$1,000.00) for services rendered herein. The Court finds that based upon the degree of difficulty and the time required to perform said appraisal, the amount of \$1,000.00 should be awarded as compensation for said appraiser's services in this matter.
