The IT department has reviewed our current backup solution with the intent to retain backup data for a longer period. We currently retain data for 30 days on file servers and want to increase that to 90 days.

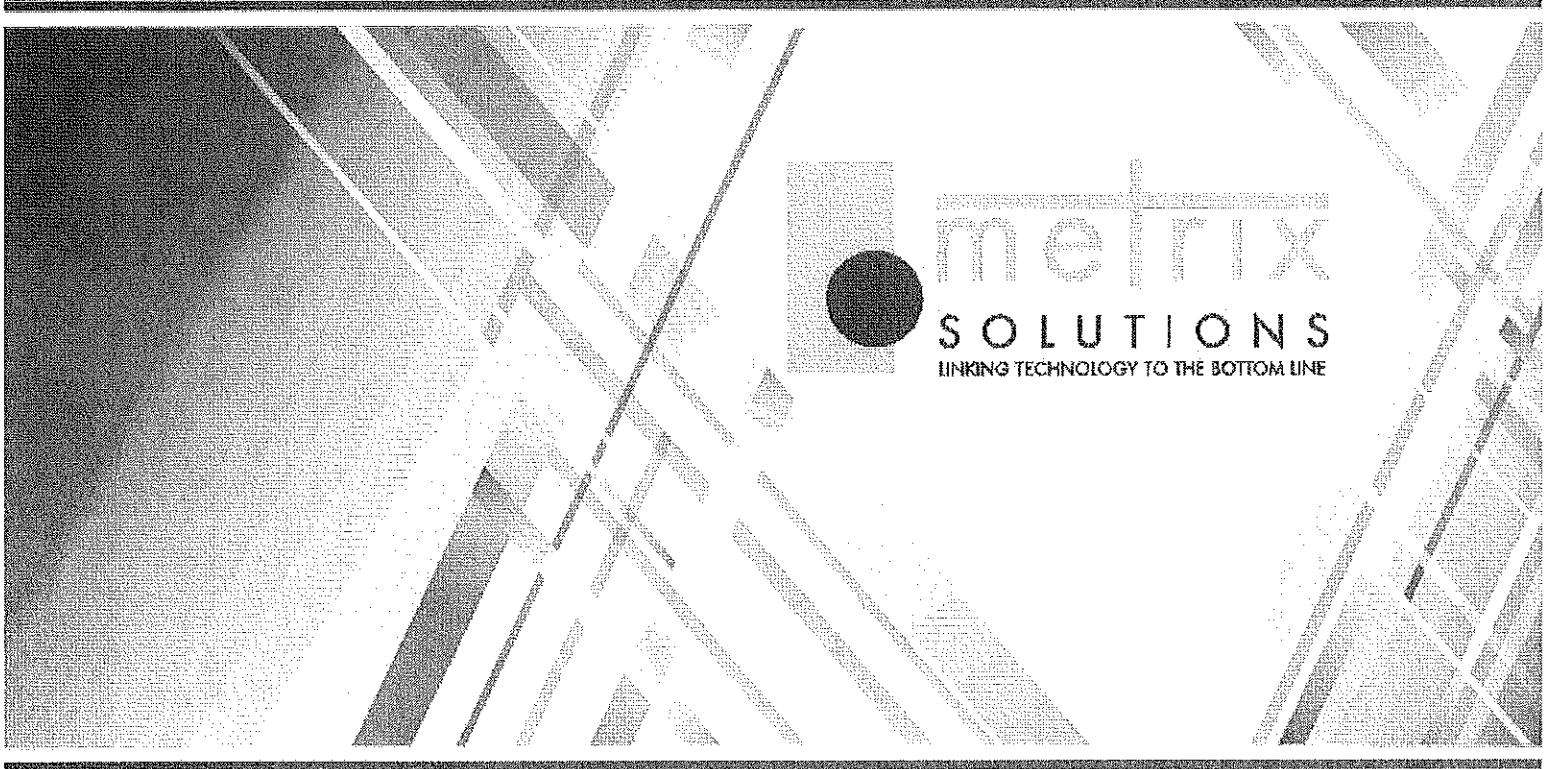
The longer retention would allow restore points further back than we can currently restore in the event of a failure.
