AGREEMENT BETWEEN MADISON COUNTY DEMOCRATIC PARTY EXECUTIVE COMMITTEE AND MADISON COUNTY ELECTION COMMISSION

WHEREAS, the primary elections for federal offices for the State of Mississippi will take place on June 7, 2022, in the Second and Third Congressional Districts to determine the Democratic nominees for the U.S. House of Representatives, with a runoff election to be held, if necessary ("Elections"); and,

WHEREAS, the Madison County Democratic Party Executive Committee (the "Democratic Party") has indicated its intent to hold said Elections;

WHEREAS, the Madison County Election Commission ("Commission") agrees to assist the Democratic Party with specific duties in its runoff election cited below upon the execution of this agreement ("Agreement"); and,

WHEREAS, during the 2001 Legislative Session, the Mississippi Legislature passed laws including, Mississippi Code Ann. § 23-15-266 and related sections, enabling County Party Executive Committees to enter into written agreements with County Election Commissions to perform certain specifies duties in a primary elections. Those agreed upon duties may be performed by the Commission following the timely signing of such agreements; and,

WHERAS, the undersigned have agreed upon the following terms of the Agreement herein for the conduct of the Runoff Election; therefore,

BE IT SO RESOLVED:

- 1. The Democratic Party shall be responsible for the hiring of its poll workers, resolution board, and election night receiving personnel and submitting the proper documentation to the County for their payment after each poll worker training and on election day.
- 2. The Election Commission pays poll workers from its budget and is responsible for being going stewards of taxpayer funds entrusted to it. Therefore, the Democratic Party agrees to limit the number of poll workers at each polling location to a reasonable proportion of its voters in that precinct as set forth in Exhibit "A." Further, the Democratic Party agrees that each polling location shall have only one receiving and returning manager who picks up on Monday night and then delivers the ballot box and materials to the Courthouse on election night. The Democratic Party agrees with the designation of which political party shall be responsible for providing a return manager on election night as set forth in Exhibit "A."

3. The Commission shall assist the Democratic Party in the training of its poll workers. This assistance shall be limited to thirty (30) poll workers per training session which both parties to this agreement will strictly enforce. Each party Chairman will attend each meeting and be responsible for securing county payroll forms, registering and submitting for payment.

4. The Commission will fill one supply box and prepare one three-ring binder of materials for each precinct. The Democratic Party agrees that it shall share these items with the Republican Party in the conduct of both parties' primary elections.

- 5. The Democratic Party must deliver to the Circuit Clerk their ballot order by precinct and/or splits if necessary by March 1, 2022. Ballot order requires that ballots be ordered for 75% of number of voters from a similar election of the same type.
- 6. The Commission will have no participation in the election eve and election day activities at the Courthouse and polling locations which will remain the responsibilities of the Democratic Party, including, but not limited to, no interaction with poll workers on election day, the delivering of voting materials to through receiving managers, the return of voting materials as designated in Exhibit "A," and processing and counting all ballots, with the exception of Affidavit Ballots discussed in number 8.
- 7. Prior to election day, the Democratic Party will oversee the programming, testing and distribution of the voting machines. The delivery trucks have to be rented ahead of time and ordered with lift gates, air suspension and straps to secure the equipment. Following election day, on Wednesday, the Democratic Party will oversee the return of the voting machines.
- 8. Tuesday night returning check-in will be conducted by each party. These teams will coordinate with the Circuit Clerk:
 - a) The C.C. will verify that any ballot bag or ballot box entering the Courthouse is sealed.
 - b) The C.C. will receive each precinct clear bag for tabulation
 - c) The C.C. will accept the Routers from each precinct
 - d) The C.C. will coordinate the Payroll Packet receipt to the county's Accounting Department
 - e) The C.C. will collect all Precinct Keys
- 9. The designated Democratic Party check-in table will collect the 3-ring binder for the precinct and verify with the "Accountability Sheet", that the following are accurate.
 - a) Verify Seal Numbers for the unused ballots inside green ballot bags;
 - b) Verify Seal Numbers for blue ballot boxes from the scanners;
 - c) Verify Seal Numbers for green affidavit ballot bags;
 - d) Receive all electronic tablets, verify serial numbers, and secure in area designated by C.C.
 - e) Receive red supply bags and attach seal of not properly sealed, recording numbers; then stack in C.C.'s Storage Closet
 - f) Transport blue bags to C.C.'s Storage Closet
- 10. The Commission will assist, as requested by the Democratic Party, in the review and assessment of affidavit ballots, including determining the status of affidavit voters on the Madison County voter rolls and in the SEMS database. The Commission's role is primarily to assist the Democratic Party in having access to the SEMS database while protecting the information of the voters that is protected by law such as social security number and date of birth. The Commission will convey their findings to the Democratic Party who shall make the final determination of whether to accept or reject each affidavit ballot.
- 11. The Commission will not be responsible for any other tasks unless agreed to in writing in a subsequent agreement.

This Agreement must be agreed to, executed by both parties and filed in the office of the Madison County Circuit Clerk by 5:00 p.m. on February 28, 2022, as condition precedent to becoming binding.
