Technology Proposal Support

On behalf of the Ridgeland Fire Department, I am requesting for financial assistance in the purchasing of eight (8) iPads, iPad accessories, iPad data plans, Smart Board and mobile stand. Having use of these devices give officers, fire fighters and inspectors access to vital information more quickly, more accurately, and in real time. Additionally, they will be utilized in training and planning.

Fire Department Background

The Ridgeland Fire Department (RFD) operates four stations staffed with fifty-seven fire fighters and five administrative personnel. We cover approximately twenty-eight square miles of 98% urban interface. The nighttime population of Ridgeland is around 25,000 but nearly doubles during the day due to a high saturation of office buildings, two malls, and various businesses attracting visitors and workers. We respond to multitude of emergencies and non-emergencies calls including fire, medical, invalid assistance and technical rescues. The annual call volume has historically hovered around 3,500 of which 85% plus are medical emergencies. One of the reasons for the high percentage of medical calls are the seven nursing homes that reside within the city limits. For this reason, all the firefighters are trained at minimum to the National Registry Emergency Medical Technician Basic(EMT-B)level and several have advanced to the Paramedic level.

Problem

The Ridgeland Fire Department (RFD) has not fully embraced and taken advantage of all the technological advances there are available. RFD utilizes Fire Bridge to track all fire response calls. However, RFD is not using this program to its full potential. Fire Bridge also allows RFD to document hydrant maintenance, hose testing, inventory management, daily/weekly/monthly truck check, vehicle maintenance, fire inspections and target hazards. Additionally, other programs would allow RFD to map

best routes to calls, complete medical patient care reports on scene (including signed refusals), identify hazardous materials, mitigate natural disasters, pre-plan for large events and complete classes on Target Solution.

Proposal Description

One way to help overcome this problem is to outfit all emergency apparatus with cellular integrated iPads. This would allow fire figthers to utilize Fire Bridge and Target Solutions to their full potential. RFD would be able to use electronic forms for nearly all daily tasks and eliminate the wasteful and antiquated paper forms. Additionally, a Smart Board would be highly useful in the Inspections office. This board would be utilized to review building plans, edit building plans and email those changes back to the building department. The Smart Board would also be used to organize and perform fire inspections, plan for large events, and mitigate natural disasters or mass casuality incidents.

Overall, this technology upgrade will save the city money and benefit the firefighters as they respond to a call. When a call is dispatched, this device can pull up a map that shows the quickest route where the nearest hydrants are to the site which will saves time and lives. Officers typically relay over the radio what the scene looks like and type of support needed. With an Ipad, officers can take a picture and send it to response teams so they are prepared on arrival. Moving from paper documents to electronic will cut cost on paper and ink and increase productivity of fire fighters, officers, and inspectors.
