### 1. Project Description

It is JH&H's understanding that JH&H Architects | Planners | Interiors, P.A. will provide AE Services for Two sets of Playground Equipment one at Rogers and one at Camden Parks in North Madison County. Scope of Project Budget is to be determined. At this time, the exact Project Scope detail is preliminary.

## 2.Scope of Basic Services to be Provided

- A. Provide Construction Drawings for the above Project Scope.
- B. Provide up to Three Meetings with County.
- C. Provide Construction Administration Services.

### 3. Fees & Costs for Basic Services

- A. Fees for Basic Services shall be 8.5% Percentage of the Total Construction Cost.
- B. Fees for Additional Services shall be at the Hourly Rates as listed in Paragraph 4. No Additional Services are to be provided unless requested and approved by the County Representative. Additional Services are those requested by the Owner beyond the Scope of Basic Services contained in Paragraph 2.
- C. Reimbursable Costs shall be as listed in Paragraph 5. Reimbursable Costs are in Addition to the Basic Services Fee.
