Registration Parameters

The parameters provided below detail procedures for registering conference attendees. **The deadline to complete online registration is June 10, 2022, at 5 p.m.**

- A. Vendors and Contract Appraisers must register as a Vendor to attend ANY part of the conference.
- B. MACA dues cover conference registration for the Assessor and/or Collector and one guest.
- C. The Guest of the Tax Assessor and/or Collector is typically a spouse or a significant other.
- D. If the Tax Assessor and/or Collector IS NOT bringing a spouse or significant other, a Deputy may be the Guest.
- E. If the Tax Assessor and/or Collector IS bringing a spouse or significant other, a Deputy must register and pay the deputy conference fee (\$150.00).
- F. **NO SPLITTING!!** If the spouse or significant other attends any portion of the conference, then the Deputy must pay the deputy conference fee of \$150.00.
- G. The Deputy registration fee is \$150.00.
- H. The guest registration fee is \$150.00.
- I. The retired Assessor/Collector fee is \$150.00.
- J. There is a separate special registration fee scale for children at the conference.
 - a. Youth ages 0-6 there is no fee.
 - b. Youth ages 6-13 the fee is \$75.
 - c. Youth ages 14 and up will be required to register as regular guests for a fee of \$150.
