The MJCCA Annual Convention will be held in *Natchez*, MS. The dates will be September 07-09, 2022.

Reservations can be made at the *Natchez Grand Hotel*. A total of **90 rooms** at the price of \$114.00 for Single, \$119.00 for Double, and \$129.00 for the Riverview per night *plus a* \$11.95 resort fee per night. Please make your reservations early, so you don't miss out on the special block.

Reservation Procedure – Individual Call-In: Attendees should make reservations at 1(601)446-9994 or (866)488-0898 and identify themselves as part of the MS Justice Court Clerks

Conference or use the code MJCC to receive the special room rate. Reservations should be made by Sunday, August 07, 2022. Reservations must be made by the Cut-off Date. Any reservations request received after this cutoff date will be accepted on a space available basis at the contracted rate, a special rate or prevailing rate available at that time, at Hotel's discretion.

All guests are responsible for their own guest room, tax, and incidental charges upon check out. Please bring a copy of your county's tax-exempt certificate and it must be presented at the time of check in. The rates are subject to a 7% Mississippi State tax and 2% occupancy tax.

If you are paying with your <u>county check</u> please inform the hotel in advance and get total price of your stay. Please make sure the check reaches the designated place fourteen (14) days prior to arriving, Natchez Grand Hotel and Suites, 111 Broadway Street, Natchez, MS 39120.
