

BOUNDARY DESCRIPTIONS
BOARD OF SUPERVISOR DISTRICTS
MADISON COUNTY, MISSISSIPPI
NOVEMBER 18, 2022

The five Board of Supervisor Districts of Madison County, Mississippi, are described as follows (in the event of a conflict between these descriptions and the map designated “Madison County Supervisors Districts Plan 2, February 3, 2022” as officially approved, the map shall control). All Corporate Limit lines are as of April 2020.

DISTRICT 1

Commence at the intersection of the centerlines of Old Canton Road and St. Augustine Drive, located near the center of the east line of Section 17, Township 07 North, Range 02 East;

thence run westerly along the centerline of St. Augustine Drive a distance of approximately 3,272 feet, to the centerline of US Highway 51;

thence run southwesterly along the centerline of US Highway 51 a distance of approximately 3,495 feet, to the centerline of to a point on the south Corporate Limit Line of the City of Madison, located near the center of the northwest quarter of the northwest quarter of Section 20, Township 07 North, Range 02 East;

thence run northerly and westerly along the south Corporate Limit Line of the City of Madison to the centerline of Interstate 55 North, located near the center of the northeast quarter of Section 13, Township 07 North, Range 01 East;

thence run northeasterly along the centerline of Interstate 55 North a distance of approximately 2,721 feet, to the centerline of Lake Castle Road;

thence run westerly along the centerline of Lake Castle Road a distance of approximately 1.16 miles, to a point on the west Corporate Limit Line of the City of Madison;

thence run northerly, westerly, and northerly along the west Corporate Limit Line of the City of Madison to the centerline of North Livingston Road, located near the center of the north line of the northeast quarter of Section 10, Township 07 North, Range 01 East;

thence run northerly and northeasterly along the centerline of North Livingston Road a distance of approximately 4,052 feet, to the centerline of State Highway 463;

thence run northwesterly along the centerline of State Highway 463 a distance of approximately 2,350 feet, to the centerline of Ingleside Drive;

thence run easterly along the centerline of Ingleside Drive a distance of approximately 1.77 miles, to the centerline of Ingleside Road;

thence run southeasterly and southerly along the centerline of Ingleside Road a distance of approximately 4,141 feet, to the centerline of Old Mannsdale Road;

thence run southeasterly along the centerline of Old Mannsdale Road to the centerline of Bozeman Road;

thence run northerly along the centerline of Bozeman Road a distance of approximately 520 feet, the north line of the south half of Section 6, Township 07 North, Range 02 East;

thence run easterly along the north line of the south half of Section 6, Township 07 North, Range 02 East a distance of approximately 3,119 feet, to the centerline of Interstate 55 North;

thence run northerly and northeasterly along the centerline of Interstate 55 North a distance of approximately 1.21 miles, to a point on the north Corporate Limit Line of the City of Madison, located near the center of the west line of the southwest quarter of the northwest quarter of Section 32, Township 08 North, Range 02 East;

thence run southerly and easterly along the north Corporate Limit Line of the City of Madison to the centerline of Green Oak Lane, located near the northeast corner of Section 4, Township 07 North, Range 02 East;

thence run easterly along the centerline of Green Oak Lane a distance of approximately 1 mile, to the centerline of Old Canton Road;

thence run easterly along the centerline of Old Canton Road a distance of approximately 1.55 miles, to the centerline of Pearl River Church Road, located near the northeast corner of the northwest quarter of Section 1, Township 07 North, Range 02 East;

thence run southerly along the centerline of Pearl River Church Road a distance of approximately 4,661 feet, to the centerline of Old Rice Road;

thence run westerly along the centerline of Old Rice Road a distance of approximately 453 feet, to the centerline of Pearl River Church Road;

thence run southerly and southeasterly along the centerline of Pearl River Church Road a distance of approximately 2,082 feet, to the centerline of The Natchez Trace;

thence run northeasterly along the centerline of The Natchez Trace a distance of approximately 1.28 miles, to a point on the south line of a certain census block (280890302083001), located near the center of the northeast quarter of Section 6, Township 07 North, Range 03 East;

thence run southeasterly along the south line of said census block (280890302083001) a distance of approximately 3,885 feet, to the east boundary line of Madison County, located near the center of Section 5, Township 07 North, Range 03 East;

thence run southwesterly along the east boundary line of Madison County a distance of approximately 6.25 miles, to a point on the east line of a certain census block (280890301071000) located near the center of the northwest quarter of Section 23, Township 07 North, Range 02 East;

thence run northerly and northeasterly along the east line of said census block (280890301071000) a distance of approximately 4,113 feet, to the centerline of The Natchez Trace, located near the east line of Section 15, Township 07 North, Range 02 East;

thence run northeasterly along the centerline of The Natchez Trace a distance of approximately 470 feet, to an easterly extension of the centerline of St. Augustine Drive;

thence run westerly along the centerline of said easterly extension of the centerline of St. Augustine Drive a distance of approximately 500 feet, to a point on the east Corporate Limit Line of the City of Madison;

thence run southerly, southwesterly, and westerly along the east Corporate Limit Line of the City of Madison to the centerline of Old Canton Road, located near the southwest corner of Section 21, Township 07 North, Range 02 East;

thence run northerly along the centerline of Old Canton Road a distance of approximately 1.48 miles, to the centerline of St. Augustine Drive, located near the center of Section 17, Township 07 North, Range 02 East, this being the POINT of BEGINNING.

DISTRICT 2

Commence at the intersection of the centerline of Old Robinson Springs Road and the west Corporate Limit Line of the City of Madison, located near the center of the northwest quarter of Section 4, Township 07 North, Range 01 East

thence run northerly, easterly, and northeasterly along the west Corporate Limit Line of the City of Madison to the centerline of State Highway 463, located near the center of Section 27, Township 08 North, Range 01 East;

thence run northerly and northwesterly along the centerline of State Highway 463 a distance of approximately 3.92 miles, to the centerline of State Highway 22, located near the center of Section 8, Township 08 North, Range 01 East;

thence run northeasterly along the centerline of State Highway 22 a distance of approximately 3.5 miles, to the centerline of Northshore Boulevard, located near the center of the southwest quarter of the northeast quarter of Section 2, Township 08 North, Range 01 East;

thence run southerly and easterly along the centerline of Northshore Boulevard a distance of approximately 2,652 feet, to the centerline of Garth Lane;

thence run southerly along the centerline of Garth Lane a distance of approximately 536 feet, to an imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line;

thence run southwesterly along said imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 1,114 feet, to the shoreline of Lake Caroline;

thence run southeasterly, westerly, and northerly along the meandering shoreline of Lake Caroline a distance of approximately 4,637 feet, to that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line, located near the center of the southeast quarter of the southeast quarter of Section 2, Township 08 North, Range 01 East;

thence run southwesterly along said imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 170 feet, to the shoreline of Lake Caroline;

thence run southerly, westerly, and northerly along the meandering shoreline of Lake Caroline a distance of approximately 1,212 feet, to that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line;

thence run southwesterly along the that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 1,142 feet, to the centerline of Lake Caroline, also being the north line of a certain census block boundary (280890304021050);

thence run easterly along the meandering centerline of Lake Caroline, also being the north line of a certain census block boundary (280890304021050) a distance of approximately 1.5 miles, to the northeast corner of said census block (280890304021050);

thence run southeasterly along the east boundary line said census block (280890304021050), also being the eastern shoreline of Lake Caroline, running parallel to Bellevue Drive a distance of approximately 2,430 feet, to the southeast corner of that certain census block (280890304021050);

thence run westerly along the meandering south boundary line of said census block (280890304021050) a distance of approximately 2,434 feet, to the shoreline of Lake Caroline;

thence run southerly along the meandering shoreline of Lake Caroline a distance of approximately 2,929 feet, to a point on the north line of Section 13, Township 08 North, Range 01 East;

thence run westerly along the north line of Section 13, Township 08 North, Range 01 East a distance of approximately 475 feet, to the centerline of Caroline Boulevard;

thence run southerly and northeasterly along the centerline of Caroline Boulevard a distance of approximately 3,046 feet, to a point on the north line of Section 13, Township 08 North, Range 01 East;

thence run easterly along the north line of Section 13, Township 08 North, Range 01 East, and continuing easterly along the north line of Section 18, Township 08 North, Range 02 East a distance of approximately 1,995 feet, to the centerline of Catlett Road;

thence run northerly along the centerline of Catlett Road a distance of approximately 185 feet, to an imaginary line running parallel to the north line of Sections 18, 17, and 16, Township 08 North, Range 02 East and offset to the north a distance of approximately 185 feet;

thence run easterly along said imaginary line running parallel to the north line of Sections 18, 17, and 16, Township 08 North, Range 02 East and offset to the north a distance of approximately 185 feet a distance of approximately 2.65 miles, to the east right-of-way of Interstate 55, located near the southeast corner of Section 9, Township 08 North, Range 02 East;

thence run northeasterly along the east right-of-way of Interstate 55 a distance of approximately 1.13 miles, to the centerline of Ragsdale Road;

thence run easterly along the centerline of Ragsdale Road and continuing along an easterly extension of the centerline of Ragsdale Road a distance of approximately 5,043 feet, to the centerline of the main line of the Canadian National Railroad right-of-way;

thence run southwesterly along the centerline of the main line of the Canadian National Railroad right-of-way a distance of approximately 2,832 feet, to a point on the north line of the south half of Section 11, Township 08 North, Range 02 East;

thence run easterly along the north line of the south half of Section 11, Township 08 North, Range 02 East a distance of approximately 1,635 feet, to the centerline of US Highway 51 North;

thence run southwesterly along the centerline of US Highway 51 North a distance of approximately 2.15 miles, to the centerline of to a point on the north line of a certain census block (28090304011036), located near the center of the southwest quarter of the northeast quarter of Section 22, Township 08 North, Range 02 East;

thence run southeasterly along the north line of a certain census block (28090304011036) South 68 degrees East a distance of approximately 750 feet; thence South 5 degrees East a distance of approximately 809 feet; thence East a distance of approximately 1,212 feet; thence North a distance of approximately 253 feet; thence East a distance of approximately 2,217 feet to the east line of said census block;

thence run southerly along the east line of said census block (28090304011036) continuing southerly along the east line of the adjacent census block (28090304011037) a distance of approximately 2,105 feet, to the centerline of Yandell Road;

thence run westerly along the centerline of Yandell Road to the centerline of Clarkdell Road, located near the northeast corner of Section 27, Township 08 North, Range 02 East;

thence run southerly along the centerline of Clarkdell Road a distance of approximately 2 feet, to the centerline of Green Oak Lane, located near the northeast corner of Section 3, Township 07 North, Range 02 East;

thence run westerly along the centerline of Green Oak Lane to a point on the north Corporate Limit Line of the City of Madison;

thence run westerly and northerly along the north Corporate Limit Line of the City of Madison to the centerline of Interstate 55 North, located near the center of the west line of the southwest quarter of the northwest quarter of Section 32, Township 08 North, Range 02 East;

thence run southeasterly and southerly along the centerline of Interstate 55 North a distance of approximately 1.21 miles, to a point on the north line of the south half of Section 6, Township 07 North, Range 02 East;

thence run westerly along the north line of the south half of Section 6, Township 07 North, Range 02 East a distance of approximately 3,119 feet, to the centerline of Bozeman Road;

thence run southerly along the centerline of Bozeman Road a distance of approximately 520 feet, to the centerline of Old Mannsdale Road;

thence run northwesterly along the centerline of Old Mannsdale Road to the centerline of Ingleside Road;

thence run northerly and northwesterly along the centerline of Ingleside Road a distance of approximately 4,141 feet, to the centerline of Ingleside Drive;

thence run westerly along the centerline of Ingleside Drive a distance of approximately 1.77 miles, to the centerline of State Highway 463;

thence run southeasterly along the centerline of State Highway 463 a distance of approximately 2,350 feet, to the centerline of North Livingston Road;

thence run southwesterly along the centerline of North Livingston Road a distance of approximately 1,600 feet, to a point on the West Corporate Limit Line of the City of Madison;

thence run northerly and westerly along the West Corporate Limit Line of the City of Madison to the centerline of Robinson Springs Road, located near the center of the northeast quarter of Section 3, Township 07 North, Range 01 East;

thence run westerly along the centerline of Robinson Springs Road a distance of approximately 1.42 miles, to the West Corporate Limit Line of the City of Madison, located near the center of the northwest quarter of Section 4, Township 07 North, Range 01 East, this being the POINT of BEGINNING.

DISTRICT 3

Commence at the intersection of the centerlines of Old Canton Road and St. Augustine Drive, located near the center of the east line of Section 17, Township 07 North, Range 02 East;

thence run westerly along the centerline of St. Augustine Drive a distance of approximately 3,272 feet, to the centerline of US Highway 51;

thence run southwesterly along the centerline of US Highway 51 a distance of approximately 3,495 feet, to the centerline of to a point on the south Corporate Limit Line of the City of Madison, located near the center of the northwest quarter of the northwest quarter of Section 20, Township 07 North, Range 02 East;

thence run northerly and westerly along the south Corporate Limit Line of the City of Madison to the centerline of Interstate 55 North, located near the center of the northeast quarter of Section 13, Township 07 North, Range 01 East;

thence run northeasterly along the centerline of Interstate 55 North a distance of approximately 2,721 feet, to the centerline of Lake Castle Road;

thence run westerly along the centerline of Lake Castle Road a distance of approximately 1.16 miles, to a point on the west Corporate Limit Line of the City of Madison;

thence run northerly, westerly, and northerly along the west Corporate Limit Line of the City of Madison to the centerline of North Livingston Road, located near the center of the north line of the northeast quarter of Section 10, Township 07 North, Range 01 East;

thence run northerly along the centerline of North Livingston Road a distance of approximately 2,492 feet, to a point on the west Corporate Limit Line of the City of Madison;

thence run northerly and westerly along the West Corporate Limit Line of the City of Madison to the centerline of Robinson Springs Road, located near the center of the northeast quarter of Section 3, Township 07 North, Range 01 East;

thence run westerly and northwesterly along the centerline of Robinson Springs Road a distance of approximately 2.75 miles, to the centerline of Coker Road, located near the center of the southwest quarter of Section 32, Township 08 North, Range 01 East;

thence run southerly along the centerline of Coker Road a distance of approximately 1.52 miles, to the centerline of Lake Cavalier Road, located near the southwest corner of Section 5, Township 07 North, Range 01 East;

thence run southerly, easterly, and southerly along the centerline of Lake Cavalier Road a distance of approximately 3.55 miles, to the centerline of North Livingston Road, located near the center of the south line of Section 16, Township 07 North, Range 01 East;

thence run southerly along the centerline of North Livingston Road a distance of approximately 1.7 miles, to the centerline of Old Agency Road, located near the center of Section 28, Township 07 North, Range 01 East;

thence run northeasterly along the centerline of Old Agency Road a distance of approximately 3,847 feet, to a point on the east line of the west half of the west half of Section 27, Township 07 North, Range 01 East;

thence run southerly along the east line of the west half of the west half of Section 27, Township 07 North, Range 01 East south line of said Section 27;

thence run easterly along the south line of said Section 27 and continue easterly along the south line of Section 26, Township 07 North Range 01 East a distance of approximately 1.36 miles, to the centerline of White Oak Creek;

thence run southeasterly along the meandering centerline of White Oak Creek to a point on the South Corporate Limit Line of the City of Ridgeland, located near the center of the northeast quarter of Section 35, Township 07 North, Range 01 East;

thence run easterly and southerly along the South Corporate Limit Line of the City of Ridgeland a distance of approximately 1.1 miles, to the centerline of West Holmes Street, located near the center of the northeast quarter of Section 36, Township 07 North, Range 01 East;

thence run easterly along the centerline of West Holmes Street a distance of approximately 1,395 feet, to the centerline of US Highway 51 North;

thence run northeasterly along the centerline of US Highway 51 North to the centerline of Lake Harbour Drive;

thence run easterly along the centerline of Lake Harbour Drive to the centerline of South Pear Orchard Road;

thence run southerly along the centerline of South Pear Orchard Road to the centerline of Towne Center Boulevard;

thence run easterly along the centerline of Towne Center Boulevard to the centerline of Northpark Drive;

thence run northeasterly along the centerline of Northpark Drive to the centerline of Harbour Pointe Crossing;

thence run easterly and southeasterly along the centerline of Harbour Pointe Crossing to the centerline of Old Canton Road;

thence run southerly along the centerline of Old Canton Road to the centerline of William Boulevard;

thence run easterly along the centerline of William Boulevard a distance of approximately 1,705 feet, to the centerline of a high voltage power transmission line right-of-way;

thence run southwesterly along the centerline of said high voltage power transmission line right-of-way to the south boundary line of Madison County;

thence run easterly along the south boundary line of Madison County to the east boundary line of Madison County;

thence run northerly along the meandering east boundary line of Madison County a distance of approximately 4.15 miles, a point on the east line of a certain census block (280890301071000) located near the center of the northwest quarter of Section 23, Township 07 North, Range 02 East;

thence run northerly and northeasterly along the east line of said census block (280890301071000) a distance of approximately 4,113 feet, to the centerline of The Natchez Trace, located near the east line of Section 15, Township 07 North, Range 02 East;

thence run northeasterly along the centerline of The Natchez Trace a distance of approximately 470 feet, to an easterly extension of the centerline of St. Augustine Drive;

thence run westerly along the centerline of said easterly extension of the centerline of St. Augustine Drive a distance of approximately 500 feet, to a point on the east Corporate Limit Line of the City of Madison;

thence run southerly, southwesterly, and westerly along the east Corporate Limit Line of the City of Madison to the centerline of Old Canton Road, located near the southwest corner of Section 21, Township 07 North, Range 02 East;

thence run northerly along the centerline of Old Canton Road a distance of approximately 1.48 miles, to the centerline of St. Augustine Drive, located near the center of Section 17, Township 07 North, Range 02 East, this being the POINT of BEGINNING.

DISTRICT 4

Commence at the intersection of the centerline of Old Robinson Springs Road and the west Corporate Limit Line of the City of Madison, located near the center of the northwest quarter of Section 4, Township 07 North, Range 01 East

thence run northerly, easterly, and northeasterly along the west Corporate Limit Line of the City of Madison to the centerline of State Highway 463, located near the center of Section 27, Township 08 North, Range 01 East;

thence run northerly and northwesterly along the centerline of State Highway 463 a distance of approximately 3.92 miles, to the centerline of State Highway 22, located near the center of Section 8, Township 08 North, Range 01 East;

thence run northeasterly along the centerline of State Highway 22 a distance of approximately 3.5 miles, to the centerline of Northshore Boulevard, located near the center of the southwest quarter of the northeast quarter of Section 2, Township 08 North, Range 01 East;

thence run southerly and easterly along the centerline of Northshore Boulevard a distance of approximately 2,652 feet, to the centerline of Garth Lane;

thence run southerly along the centerline of Garth Lane a distance of approximately 536 feet, to an imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line;

thence run southwesterly along said imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 1,114 feet, to the shoreline of Lake Caroline;

thence run southeasterly, westerly, and northerly along the meandering shoreline of Lake Caroline a distance of approximately 4,637 feet, to that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line, located near the center of the southeast quarter of the southeast quarter of Section 2, Township 08 North, Range 01 East;

thence run southwesterly along said imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 170 feet, to the shoreline of Lake Caroline;

thence run southerly, westerly, and northerly along the meandering shoreline of Lake Caroline a distance of approximately 1,212 feet, to that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line;

thence run southwesterly along the that certain imaginary line running parallel to and offset northwesterly approximately 165 feet from the centerline of a high-power transmission line a distance of approximately 1,142 feet, to the centerline of Lake Caroline, also being the north line of a certain census block boundary (280890304021050);

thence run easterly along the meandering centerline of Lake Caroline, also being the north line of a certain census block boundary (280890304021050) a distance of approximately 1.5 miles, to the northeast corner of said census block (280890304021050);

thence run southeasterly along the east boundary line said census block (280890304021050), also being the eastern shoreline of Lake Caroline, running parallel to Bellevue Drive a distance of approximately 2,430 feet, to the southeast corner of that certain census block (280890304021050);

thence run westerly along the meandering south boundary line of said census block (280890304021050) a distance of approximately 2,434 feet, to the shoreline of Lake Caroline;

thence run southerly along the meandering shoreline of Lake Caroline a distance of approximately 2,929 feet, to a point on the north line of Section 13, Township 08 North, Range 1 East;

thence run westerly along the north line of Section 13, Township 08 North, Range 1 East a distance of approximately 475 feet, to the centerline of Caroline Boulevard;

thence run southerly and northeasterly along the centerline of Caroline Boulevard a distance of approximately 3,046 feet, to a point on the north line of Section 13, Township 08 North, Range 01 East;

thence run easterly along the north line of Section 13, Township 08 North, Range 01 East, and continuing easterly along the north line of Section 18, Township 08 North, Range 02 East a distance of approximately 1,995 feet, to the centerline of Catlett Road;

thence run northerly along the centerline of Catlett Road a distance of approximately 185 feet, to an imaginary line running parallel to the north line of Sections 18, 17, and 16, Township 08 North, Range 02 East and offset to the north a distance of approximately 185 feet;

thence run easterly along said imaginary line running parallel to the north line of Sections 18, 17, and 16, Township 08 North, Range 02 East and offset to the north a distance of approximately 185 feet a distance of approximately 2.65 miles, to the east right-of-way of Interstate 55, located near the southeast corner of Section 9, Township 08 North, Range 02 East;

thence run northeasterly along the east right-of-way of Interstate 55 a distance of approximately 1.13 miles, to the centerline of Ragsdale Road;

thence run easterly along the centerline of Ragsdale Road and continuing along an easterly extension of the centerline of Ragsdale Road a distance of approximately 5,043 feet, to the centerline of the main line of the Canadian National Railroad right-of-way;

thence run southwesterly along the centerline of the main line of the Canadian National Railroad right-of-way a distance of approximately 2,832 feet, to a point on the north line of the south half of Section 11, Township 08 North, Range 02 East;

thence run easterly along the north line of the south half of Section 11, Township 08 North, Range 02 East a distance of approximately 1,635 feet, to the centerline of US Highway 51 North;

thence run northeasterly along the centerline of US Highway 51 North a distance of approximately 1.93 miles, to the centerline of Old Canton Road;

thence run southeasterly and southerly along the centerline of Old Canton Road a distance of approximately 1,895 feet, to a point located near the center of the south line of Section 36, Township 09 North, Range 02 East;

thence run easterly along the south line of Section 36, Township 09 North, Range 02 East and continuing easterly along the south line of Section 31, Township 09 North, Range 03 East a distance of approximately 1.27 miles, to the centerline of Little Bear Creek;

thence run northerly and easterly along the meandering centerline of Little Bear Creek a distance of approximately 3.42 miles, a southeasterly extension of the centerline of Woodale Drive, located near the center of the northwest quarter of Section 32, Township 09 North, Range 03 East;

thence run northwesterly and northerly along the centerline of said southeasterly extension of the centerline of Woodale Drive and continue along the centerline of Woodale Drive a distance of approximately 1.12 miles, to the centerline of West Kathy Circle;

thence run westerly and northeasterly along the centerline of West Kathy Circle to the centerline of South Monroe Street;

thence run northeasterly along the centerline of South Monroe Street to the centerline of East Dinkins Street;

thence run westerly along the centerline of East Dinkins Street to the centerline of South Liberty Street (US Highway 51 North);

thence run northerly along the centerline of South Liberty Street (US Highway 51 North) to the centerline of West Peace Street;

thence run westerly along the centerline of West Peace Street to the centerline of North Canal Street;

thence run northerly along the centerline of North Canal Street to the centerline of Lutz Street;

thence run southerly along the west boundary line of Madison County to the south boundary line of Madison County;

thence run easterly along the south boundary line of Madison County to the east boundary line of Madison County;

thence run northerly along the east boundary line of Madison County a distance of approximately 4.15 miles, to a point on the east line of a certain census block (280890301071000) located near the center of the northwest quarter of Section 23, Township 07 North, Range 02 East;

thence run northerly and northeasterly along the east line of said census block (280890301071000) a distance of approximately 4,113 feet, to the centerline of The Natchez Trace, located near the east line of Section 15, Township 07 North, Range 02 East;

thence run northeasterly along the centerline of The Natchez Trace a distance of approximately 470 feet, to an easterly extension of the centerline of St. Augustine Drive;

thence run westerly along the centerline of said easterly extension of the centerline of St. Augustine Drive and continue westerly along the centerline of St. Augustine Drive a distance of approximately 1.11 miles, to the centerline of Rice Road, located near the center of the east line of Section 16, Township 07 North, Range 02 East;

thence run southerly along the centerline of Rice Road a distance of approximately 1.56 miles, to a point on the north Corporate Limit Line of the City of Ridgeland, located near the northwest corner of Section 27, Township 07 North, Range 02 East;

thence run westerly, northerly, and westerly along the north Corporate Limit Line of the City of Ridgeland to the centerline of Interstate 55, located near the center of the north line of the southeast quarter of Section 13, Township 07 North, Range 01 East;

thence run northeasterly along the centerline of Interstate 55 a distance of approximately 2.22 miles, to the centerline of to a point on the north line of the south half of Section 6, Township 07 North, Range 02 East;

thence run westerly along the north line of the south half of Section 6, Township 07 North, Range 02 East a distance of approximately 3,119 feet, to the centerline of Bozeman Road;

thence run southerly along the centerline of Bozeman Road a distance of approximately 2,755 feet, to the centerline of State Highway 463, located near the southwest corner of Section 6, Township 07 North, Range 02 East, this being the POINT of BEGINNING.
