Warranty Period

- o Hardware warranty For a period of one year from the date of shipment, 3M's hardware warranty provides free repair or replacement of faulty equipment (does not include equipment damaged by the customer or due to a Force Majeure event such as acts of God, acts of a public enemy, fires, floods, hurricanes, wars, civil disturbances, acts of terrorism, etc). The warranty does not cover the travel expenses associated with a required site visit. The engineering labor is provided at no cost to the customer. The customer is responsible for all travel and living expenses associated with the site visit.
- o Software warranty For a period of 90-days, 3M warrants the software media to be free from defects and will replace any defective media at 3M's expense. 3M will endeavor to resolve any reported software bugs (based on classification of the bug as either critical (negatively impacts program's ability to function – immediately work to resolve).

Hardware Maintenance

- Extends initial hardware warranty for an additional year to provide free repair or replacement of faulty equipment in accordance with the initial warranty terms.
- o Provides access to 3M technical phone support during normal support hours (7:00 am to 6:00 pm Central time).

Software Maintenance

- Extends initial software warranty for an additional year of coverage for continued
 3M response to software issues as defined in the Software Warranty.
- o Provided access to 3M technical phone support during normal support hours (7:00 am to 6:00 pm Central time).
