# Jackson MPO Call for Projects

The Jackson Metropolitan Planning Organization (MPO) is announcing a "Call for Projects" for consideration of funding for Federal Surface Transportation Program (STP) funds available to eligible applicants.

#### Available Funds:

Funding is being made available to the Jackson MPO through the recent Transportation Bill, Moving Ahead for Progress in the 21<sup>st</sup> Century (MAP-21). The Planning Policy Committee has established priority funding for the following categories:

Capacity Deficiency Project Types	\$16,725,000
Traffic Operational Improvements	\$1,115,000
Pavement Management Project Types	\$3,791,000
Small Municipalities	\$669,000
<b>Total Available Funding</b>	<b>\$22,300,000</b>

#### Evaluation Criteria & Application Document:

All proposals seeking funding will be evaluated and prioritized according to the adopted Project Submittal Guidelines. Blank applications can be obtained by contacting MPO staff or visiting <http://www.cmpdd.org/transportation/>

#### Submission Instructions:

Submit one (1) original proposal with three (3) copies of all required documentation in a sealed envelope. Each proposal should be typed on letter size paper bound in a three-prong or 3-ring binder.

All proposals must include the following:

- Cover letter from the principal elected official or chief executive
- Completed Application
- An appendix of required documents such as matching funds resolution and project map, as well as any additional documentation that helps support the project

All proposals must be received by Central Mississippi Planning and Development District (CMPDD) through mail or hand-delivery **by 4:30 P.M., Wednesday, October 16, 2013**. *All applications received after the deadline will be rejected.*
