## **MEMORANDUM**

TO: MADISON COUNTY BOARD OF SUPERVISORS

RE: REQUEST TO VOID TAX SALE, PARCEL NUMBER 114H-34-003/03.00

### MESSAGE:

The Record Owner phoned the Chancery Clerk's Office in early August, 2013, to determine the delinquent tax amounts due for 2010 and 2011. He also spoke with the Tax Collector's Office who gave him the amount due for the 2012 taxes. The Record Owner forwarded to our office a check which included amounts for 2010, 2011 and 2012 taxes with no explanation. We executed releases for 2010 and 2011 and refunded him \$2.90 on August 21, 2013. On Monday, August 26, 2013, the Tax Collector sold the parcel at the Land Sale for delinquent taxes in the amount of \$5.53 (\$2.36 raw taxes). The Owner spoke with me by telephone after receiving the refund from our office and explained that the additional money which had been refunded was to pay the 2012 taxes before the tax sale.

Since the tax payer made every reasonable effort to pay his 2012 taxes prior to the Land Sale, It is my request that the Board void the 2012 sale as it relates to this particular parcel; refund the purchaser, and direct the Tax Collector to accept payment from the land owner for 2012 taxes owed the county before the Land Sale in the amount of \$2.36.

Refund to the Purchaser should be made as follows:
