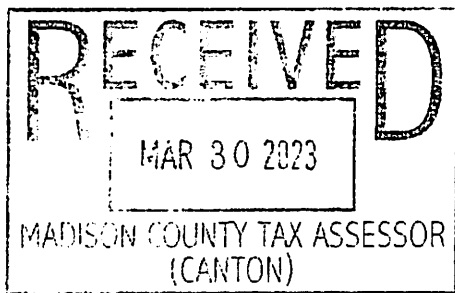

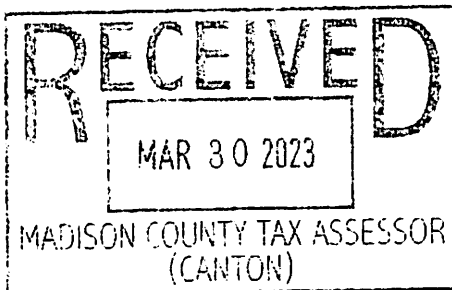

A freeport warehouse application for AM/NS Calvert LLC Steel Technologies was received by the Madison County Tax Assessor's office on March 30, 2023.

MS Code 27-31-51 Freeport Warehouse Exemption is an exemption for finished goods inventory that has been transferred to a licensed storage facility in Mississippi in route to a destination outside of the State of Mississippi. Once transferred to a licensed storage facility, the inventory cannot be changed in form.

It is the understanding of the Tax Assessor's office that the inventory owned by AM/NS Calvert LLC changes in size before leaving the facility located at 576 Church Road, Madison, MS – Therefore, would not qualify for the exemption.
