The Madison County Board of Supervisors hereby approves a salary increase for all Madison County employees not employed by the Madison County Sheriff's Office (MCSO) or the Madison County District Attorney (MCDA). The increase for any county employee not employed by MCSO or MCDA who makes less than \$50,000 per year shall be 5% of their hourly or monthly pay. Any non-MCSO, non-MCDA employees making more than \$50,000 shall receive a raise of 3% of their hourly or monthly pay. The raises shall take effect for the first payroll period of Fiscal Year 2024. The first payroll period begins October 8, 2023.
