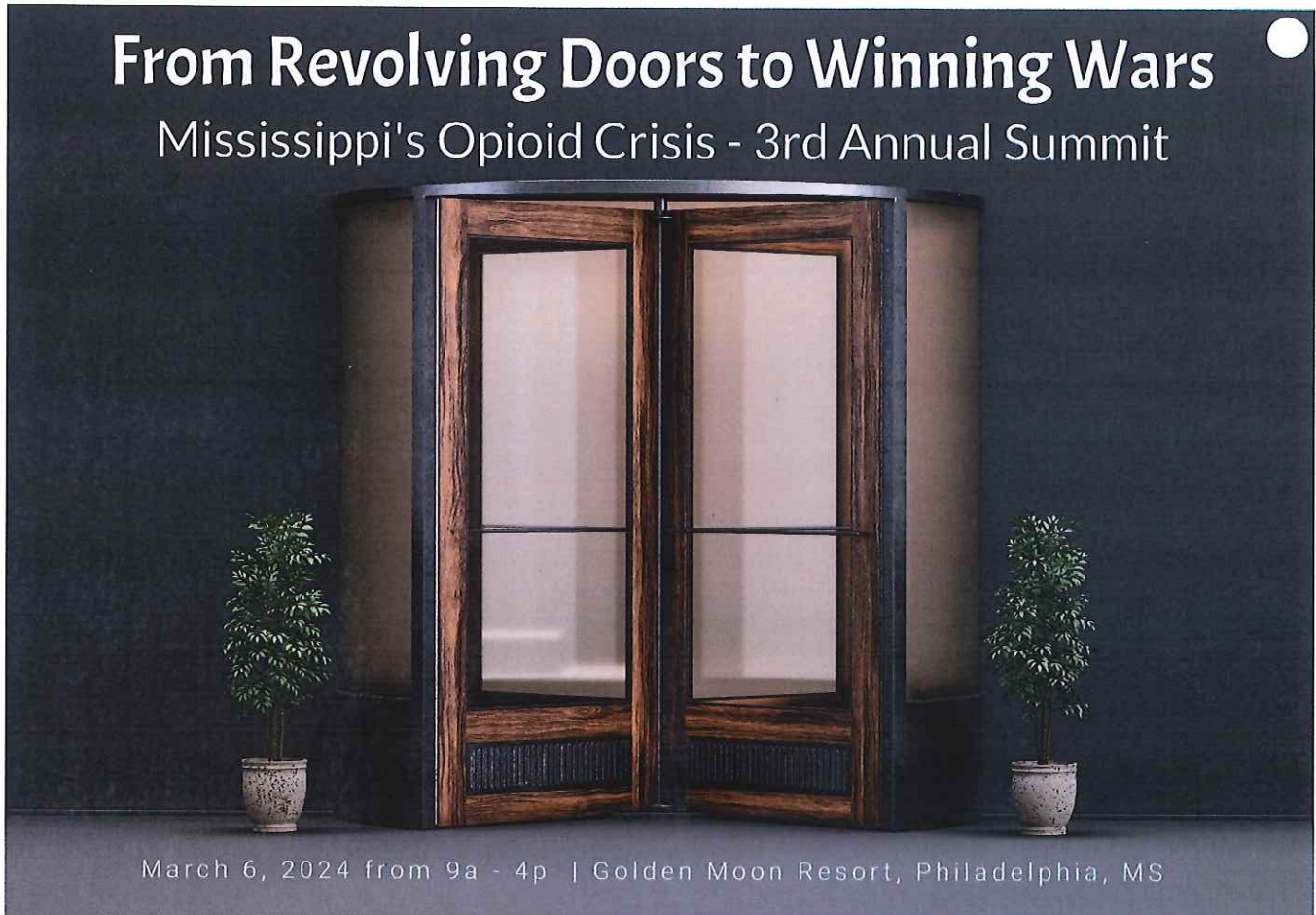

Judge Linda Davis was appointed to the bench on March 27, 2000, by Michigan Governor John Engler. Prior to her judgeship, she spent 13 years as an Assistant Prosecutor with the Macomb County Prosecutor's Office. Davis played a crucial role in [Families Against Narcotics'](#) inception and, as its Executive Director, has been instrumental in the success and growth of the organization. She was recently appointed as a voting member of the new Opioid Advisory Commission in Michigan, which will determine how funds from the National Opioid Settlement will be spent in the state.
