Upon review, an improvement that was located on parcel 105F-23 -028/00.00 was incorrectly assessed to a different parcel, 105F-23 -018/00.00. The Tax Assessor's office has taken steps to remove the value of the improvement from parcel 105F-23 -018/00.00 for tax years 2022 and 2023. Subsequently, we need to take steps to assess the improvement value to parcel 105F-23 -028/00.00.

27-35-155 allows for assessment of personal and real property having escaped taxation for former tax years for a period of up to seven years. It is this office's request that parcel 105F-23 -028/00.00 be assessed for the improvement value for tax year 2022 under the purview of code 27-35-155.
