**NOTICE OF PROPOSED AMENDMENT TO
SCOTT COUNTY SOLID WASTE MANAGEMENT PLAN**

The Scott County Board of Supervisors is requesting public comment for a period of thirty (30) days commencing on October 11, 2023, and continuing for a period of thirty (30) days thereafter, regarding a proposed change to the Scott County Solid Waste Management Plan, as follows:

Denali Water Solutions, (Applicant), whose mailing address is P.O. Box 3036, Russellville, AR 72802, has made application to the Mississippi Department of Environmental Quality, Office of Pollution Control, Nonhazardous Waste Branch for a permit to establish land application sites in Scott County. Specifically, the sites are as follows: CG-1 – CG-6, ~583 acres in Sections 20, 28, 29 & 30, T7N, R8E; DD-1, ~481 acres in Section 29, T7N, R9E, and JM-1, ~700 acres in Section 36, T6N, R9E. The acreages listed are subject to buffer zones around property lines, public roads, residences, public spaces, and surface waters.

The proposed purpose of the sites is to beneficially reuse biosolids, which meet or exceed all state and federal standards, from municipal wastewater treatment facilities. The approved service area includes municipalities located within the following Mississippi counties: Humphreys, Coahoma, Quitman, Bolivar, Sunflower, Tallahatchie, Leflore, Washington, Grenada, Carroll, Montgomery, Webster, Choctaw, Sharkey, Yazoo, Holmes, Attala, Winston, Neshoba, Leake, Madison, Issaquena, Warren, Hinds, Rankin, Scott, Newton, Jasper, Smith, Simpson, Copiah, Clay, Clairborne, Covington, Jones, Forrest, and Pike. The sites listed are privately owned and will not be open to the public.

A copy of the application and maps depicting the proposed sites may be reviewed at the Scott County Chancery Clerk's office, P.O. Box 630, 101 E. 1st Street, Forest, Scott County, MS 39074 during normal business hours. Written comments may be received at the same location.

A public hearing will be conducted December 4, 2023 at 10:00 a.m. at the Scott County Board of Supervisors' meeting room in the addition to the Chancery Clerk's office.
