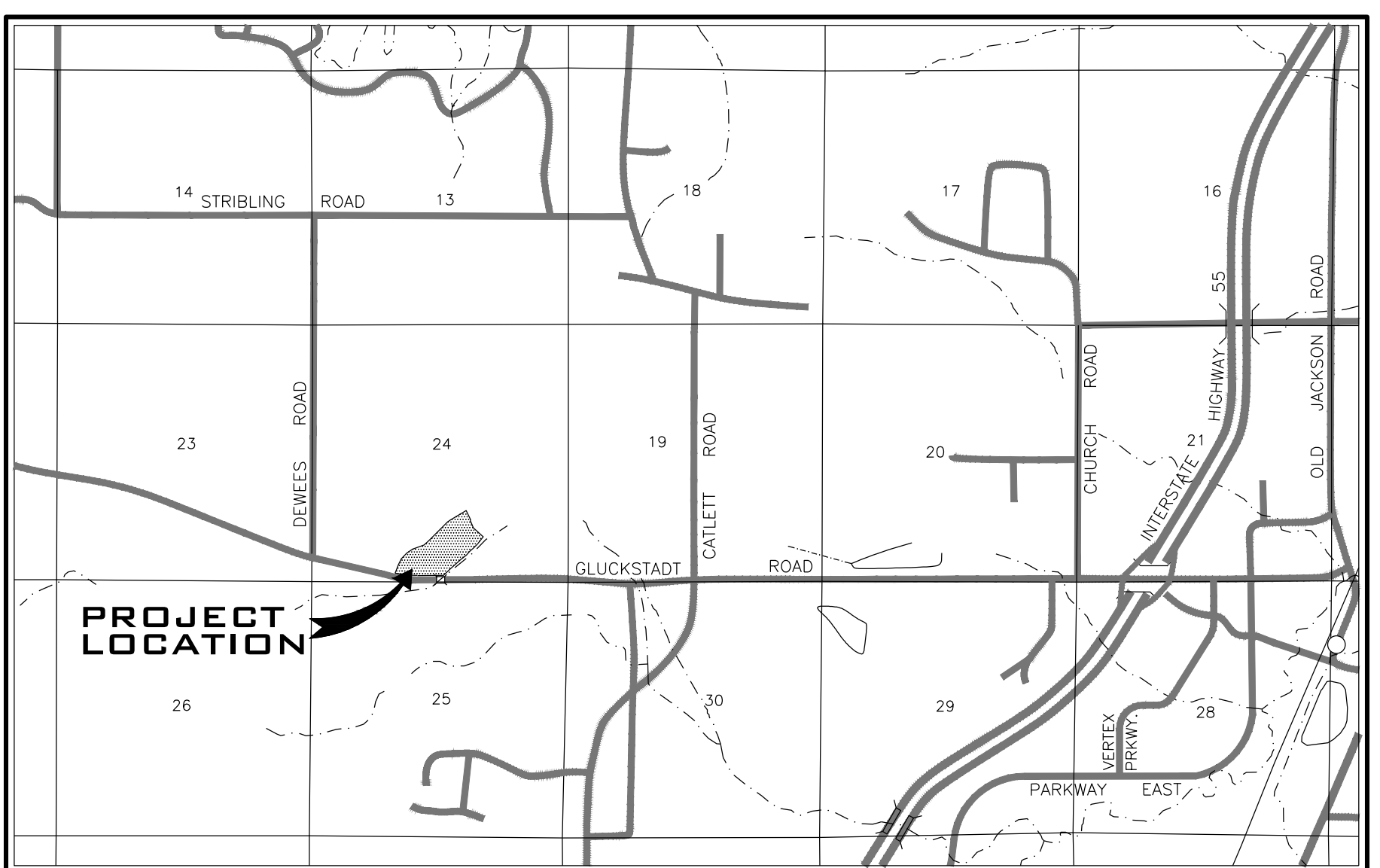
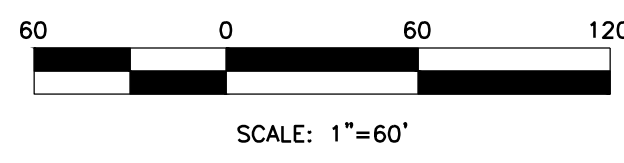

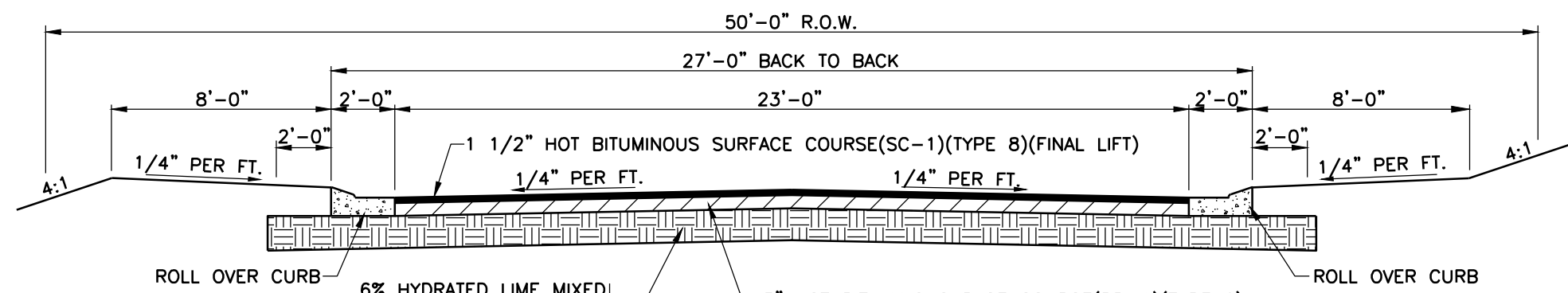

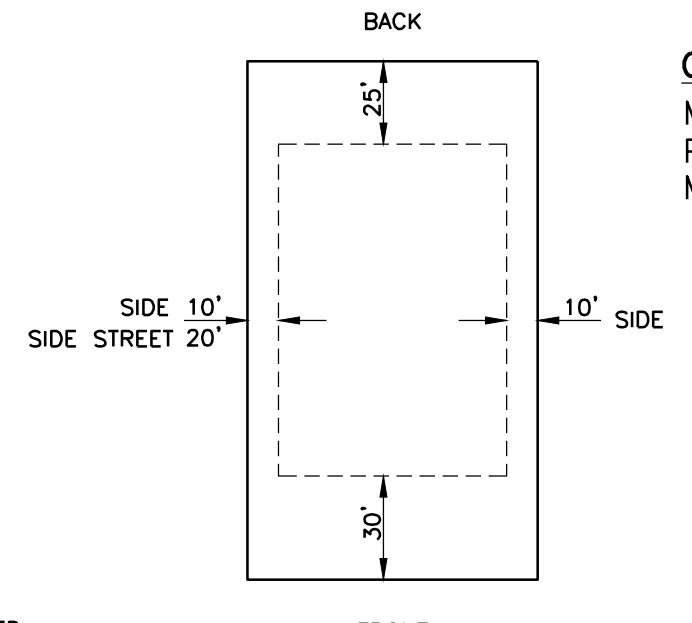
VICINITY MAP

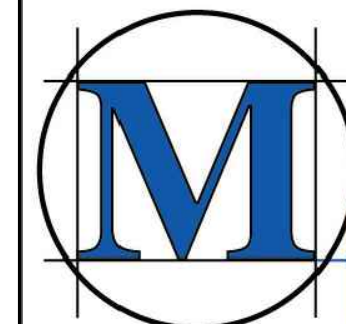
