ESCROW AGREEMENT

The undersigned Escrow Agent acknowledges receipt of the sum of Fifteen Thousand Dollars and no/100 (\$15,000.00) from **Black River Timber & Wildlife, LLC** ("Owner") to be held in escrow until the logging operations at Deer Ridge Drive, Flora, Madison County, Mississippi have been completed without damage to Deer Ridge Drive.

Escrow Agent shall be authorized in writing by Madison County, Mississippi and Owner to release the escrowed funds to Owner in the event of no damage to Deer Ridge Drive.

In the event that Escrow Agent is notified in writing that the funds should not be released because of damage to Deer Ridge Drive, Escrow Agent shall hold the funds until further written notice from Madison County, Mississippi.

The Escrow Agent shall hold and disburse the escrow funds in accordance with the terms of this Agreement. The undersigned agree and acknowledge that the Escrow Agent assumes no liability in connection with this agreement except for gross negligence or wilful misconduct.


If a dispute arises, the Escrow Agent shall have the right to interplead the escrow funds into a court of competent jurisdiction and shall be discharged from any further obligation in connection with this agreement, it being understood that any attorney's fees for the filing of such action shall be deducted from the escrowed funds.
