<i>Block of Time (BOT) – Hours presented will be used for the services described in the quote. Any hours remaining after project is completed can be used for future projects or support. If services require more hours than included in the block of time, customer can choose to purchase a new BOT or purchase the additional services by the hour.</i>
