This letter is to inform you that Entergy Mississippi, LLC. - (“Entergy”) is preparing to perform improvements to the existing overhead transmission line that is located on or adjacent to property you own in Madison County, MS. These improvements will include upgrading the existing pole structures and conductors to support increased demand for power along the South Canton-Pickens transmission line corridor.

Entergy and its contractors will be performing on-site inspections of facilities along the existing route. Some of these activities are underway. The actual rebuild has a target start date of March of 2024.

Please understand that Entergy will make every effort to use the existing Right-of-Way as access to the facilities, but if unforeseen circumstances arise, an alternative route enabling access to the transmission line facilities will need to be found. Entergy plans to discuss any such access issues with the affected landowners prior to start of construction activities.

You will find enclosed an information sheet concerning your parcel and contact information. Please use this sheet to advise us of any access issues, locked gates, preferred ingress/egress requests, etc. We will advise the construction crews of these requests. Please return the Landowner Information Sheet in the enclosed self-addressed envelope.
